ONE PATRICIO RETVEZ, A CUBAN CITIZEN, EMPLOYED HAVANA OFFICE SUN LIFE ASSURANCE CO. (A CANADIAN CORPORATION) WAS RECENTLY FERRING ON TRIP FROM CUBA AND RETURN. PATRICIO STATED THAT GOC KEEPS THREE BETAVIDIA AIRCRAFT ON ALERT STATUS AT HAVANA AIRPORT IN EVENT LEASERS HAVE TO EVACUATE FOR UPRISING OR OTHER CAUSES.
