1. AMBANG-1 CONTACTED 4DEC BY WIESINGER WHO BRIEFED HIM RE 3
 DEC AMPITH DISCUSSIONS WITH AMCHIRP-1 AND DESIRE GET AMPITH OFF GROUND
 SOONEST.

2. BANG-1 REITERATED HIS WILLINGNESS TO WORK WITH WIESINGER ACROSS
 BOARD ON KUTUBE ACTIVITIES. THEN RECALLED PAST EXPERIENCES DEALING WITH
 BENDER AND JIM SMITH OF "KUBARK" AND EXPRESSED HOPE WIESINGER WOULD
 CARRY OUT HIS ROLE ASSISTING BANG-1 ORGANIZE AMPITH. (THERE NO IMPLI-
 CATION OF TIE IN OF WIESINGER WITH KUBARK OR WITH BENDER/JIM SMITH).

3. WIESINGER BROUGHT UP BANG-1 DESIRE TALK WITH OLIEN AND ADVISED
 HE OLIEN DESIGNEE FOR PURPOSE TALK REQUESTED. BANG-1 SAID WOULD
 GLADLY DISCUSS HIS PROBLEMS AND STATED:

A. PRIOR BANG-1 ARRIVAL PUPRIME HE HAD DISCUSSION WITH OLIEN
 AND HAVA AMBASSADOR RE AIMS MRP AND MRP NEED OF ODYOKE SUPPORT CARRY
 OUT OBJECTIVES. ALTHO HE RECEIVED NO SPECIFIC COMMITMENTS RE SUPPORT,
 SINCE IN HIS BELIEF AIMS MRP COMPATIBLE OVERALL ODYOKE INTERESTS OUBA,
 DISCUSSIONS GAVE BANG-1 MORALE LIFT WITH BRIGHT OUTLOOK TOWARD
 ACCOMPLISHING GOAL MRP. IN BANG-1 MIND SUPPORT WOULD BE FORTHCOMING

ONCE HE ARRIVED PBPRIE AND NECESSARY CONTACT ESTABLISHED.

B. BANG-1 CONSIDERED HIS FIRST CONTACT WITH BENDER SATISFACTORY. HE FELT BENDER TRYING SELL FRD BY OFFERING \$12,000 AND LATER NEW YORK MEETING ATTEMPT MAKE TWO WAY PAYMENT, ONE DIRECT TO BANG-1, REMAINDER THRU FRD. BANG-1 STATED HE REFUSED ACCEPT REMAINDER AMOUNT VIA FRD CHANNELS. ADDED HE HAS NO AXE GRIND PERSONALLY RE FRD BUT IN HIS OPINION FRD APPROACH TO OVERALL CUBAN PROBLEMS ONLY TEMPORARY SOLUTION AND WILL NOT PROVIDE SOLID FUTURE GOVT FOR PEOPLE OF CUBA. BANG-1 SAID CASTRO GOV'NALL SHOULD COME FROM WITHIN AND BE CAUSED BY CUBAN PEOPLE. BANG-1 RECOGNIZED FACT ODYOKS SUPPORT VERY MUCH NEEDED BUT ODYOKS HAND SHOULD BE IN BACKGROUND AND NOT AS IN CASE FRD MOTIVATING FORCE WHICH COMMON KNOWLEDGE CUBA. BANG-1 SAID FRD COULD NOT REMOVE CASTRO WITH THEIR PRESENT APPROACH TO THE PROBLEM. BANG-1 SAID HE NOT IN PBPRIE TO FIGHT WITH FRD/BENDER OR KUBARK. HOWEVER DID NOT PLAN WORK FURTHER WITH BENDER.

C. BANG-1 MENTIONED FAILURE ISLE OF PINES OPS AND SAID HIS OPINION JIM SMITH'S BOSS BENDER DID NOT WANT SMITH FORWARD PAPER WITH KEY TO OPS TO HAVA AS REQUESTED BY BANG-1 BECAUSE THIS XRP OP (SEE ^{NASH} GOLD 1855 AND UFGA 408). BANG-1 MENTIONED THAT HIS KEY MAN IN THE OPERATION HAD BEEN TRANSFERRED FROM ISLE OF PINES. *[Copy to or Pad. No. ?]*

4. WIESINGER OPINION ABOVE MEETING HAD NO ADVERSE EFFECTS RELATIONSHIP WITH BANG-1. (END OF MESSAGE)
