WH Comment: *AMIRE-1's cover company has instructed him leave Cuba. Says can remain on his own account without complete break with the company, but that he must have an additional \$300 a month retroactive to 1 November. AMIRE-1 carrying heavy load, taking heavy risks. Recommend approval. Advise soonest.
