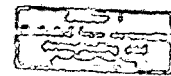
1. AT THIS TIME (1000 LOCAL) STATION HAS LOST CONTACT WITH SUBJECT. FOLLOWING IS SEQUENCE OF EVENTS.

2. EVENING 30 DEC SUBJECT WAS GIVEN DOWN-PAYMENT OF \$1,500 DOLLARS. HIS LUGGAGE WAS REMOVED FROM HOTEL AGNES WITHOUT INCIDENT. A CZECH VALTHER AUTOMATIC LOADED WITH NINE CARTRIDGES WAS REMOVED FROM SUBJECTS

LUGGAGE BY LITEMPOS. BARKER PURCHASED TICKETS IN ALIAS FOR MNTY FLIGHT 0800 MORNING 31 DEC. PLANNED IMMEDIATE DEPARTURE WAS AT SUBJECT'S REQUEST. BARKER AND SUBJECT SPENT NIGHT AT SAFEHOUSE. EITHER BARKER OR CHOADEN WERE WITH HIM AT ALL TIMES AND HE DID NOT COMMUNICATE WITH OTHER PERSONS. HIS HAND BAG GIVEN TO HIM BUT REMAINING THREE PIECES LUGGAGE RETAINED. MORNING 31 DEC SUBJECT AND BARKER DEPARTED FOR AIRPORT. SUBJECT ABRUPTLY ANNOUNCED THAT HE WOULD NOT GO AIRPORT, BUT WISHED REMAIN MEXI. FOR SEVERAL BLOCKS ATTEMPTED STEP OUT OF MOVING AUTO. REFUSED EVEN GO TO AIRPORT DESPITE PROMISE HE WOULD NOT BE FORCED TAKE PLANE. FINALLY LEFT CAR BUT AGREED WOULD MEET BARKER AND CHOADEN AT COFFEE

SNOW LOCAL HOTEL AT 0900. - DANGER VERY HIGH TO ATTEMPT ESCAPE
AND RELEASE SECURITY DETAIL. RETURNED TO HOTEL BUT SUBJECT DID
NOT SHOW AS OF 0945. LUGGAGE EXCEPT FOR HATD BAG NOT IN STATION.
PRELIMINARY INSPECTION REVEALS NOTHING OTHER THAN LARGE QUANTITY
NEW CLOTHES AND ONE HALF WALKIE-TALKIE SET.

3. SUBJECT BELIEVES HIS CONVERSATION WITH STATION AND H. LAYNE
^{SP} OFFICERS WAS RECORDED. HE CERTAINLY AWARE HIS DIFFICULT POSITION
WITH PERHAPS AFTER MISSING FLIGHT AND AFTER HAVING LUGGAGE
REMOVED FROM HOTEL BY POLICE TYPES.

4. STATION MAKING EVERY ATTEMPT RELOCATE, WITH COOPERATION
LUIS ECHEVARRIA WILL ADVISE.
