The KUTUBE/INT comments in Reference A regarding the LIFEAT Project do not present an accurate indication of Headquarters judgement of the value of the Project. These comments were passed along as the KUTUBE/INT reviewer's evaluation of the intelligence production only. The Station and Headquarters are both aware that LIFEAT is considered one of the best Project of its type and that the Project is designed mainly to provide operational reporting. The Mexican Desk agrees with the Station that targets such as ESLARD-1 should be considered as of more than "routine interest". The KUTUBE comments do not mean that Headquarters is considering a shift of emphasis in the Project's targets.</p> <p>2. A representative from KUTUBE/ops is visiting the Station during the week of 22 September to study the LIENVOY and LIFEAT Projects since these Projects are considered uniquely productive.
