1. SINCE FORWARDING REF A AMPAL-1 REPORTS CAUSE OF DISSENSION WITHIN
INTERNAL AMYUM-1 GROUP MORE EXTENSIVE THAN FINANCIAL TROUBLES. APPEARS THAT
LORIE/AMBIDDY SPLIT HAS CAUSED SERIOUS INTERNAL REPERCUSSIONS IN TERMS AMYUM-1
GROUP RECEIVING VIA THEIR CHANNELS FROM MASH THAT ODOYKE NOW SUPPORTING LORIE,
NINO DIAZ AND DIAZ LANZ. AMYUM-1 GROUP FEELS ODOYKE MERELY "USING" THEM WHILE
BACKING OTHER "MERCENARY" FACTIONS AND ABANDONING SUPPORT FOR AMBIDDY-1.
