1. NEW YORK TIMES OF 21 SEPT 75 ON FRONT PAGE CARRIES ARTICLE BY NICHOLAS HOOROCK TO EFFECT THAT AGENCY INTERCEPTED TELEPHONE CALLS BETWEEN LEE HARVEY OSWALD AND SOVIET AND CUBAN EMBASSIES IN MEXICO CITY IN LATE SEPTEMBER AND EARLY OCTOBER 1963.4

2. FYI ONLY: BACKGROUND TO ABOVE IS THAT HQS LEARNED THAT HOOROCK HAD INFO ON MEXICAN PARTICIPATION IN TELETAP ON OSWALD AND WAS PLANNING TO WRITE ARTICLE. IN ORDER TO SET RECORD STRAIGHT AND AVOID PRESS MENTION OF MEXICAN INVOLVEMENT, AGENCY PROVIDED STATEMENT WHICH APPEARS IN THE TIMES ARTICLE.4

3. NOTE AGENCY'S STATEMENT DOES NOT ATTRIBUTE INFO RECEIVED ON OSWALD TO A TELEPHONE TAP. WHILE HOOROCK REVEALS THIS HE DOES NOT MENTION MEXICAN INVOLVEMENT.4
