- F. 1962: OFFICIAL BRITISH RECORDS DO NOT REFLECT OSWALD RETURNED UNITED STETES FROM USSR THROUGH UNITED KINGDOM. HOWEVER IF HE WERE MERELY TRANSITING IT WOULD NOT HAVE BEEN NECESSARY FOR HIM FILL OUT LANDING CARD AND THEREFORE THERE WOULD BE NO RECORD HIS TRAVEL IN OFFICIAL TRAFFIC INDEX.
