1. Your attention is invited to the attached Bureau memorandum concerning Subject.
2. The latest information from the Bureau concerning Subject indicated that as of September 1960 he was still associated with QDBIAS, but one Bureau source indicated in August of 1960 that Subject and QDBIAS had had a disagreement. The basis for the disagreement was not detailed.
3. Because of QDBIAS' later associations with AMIRON, it is requested that WAVE attempt to clarify Subject's current status vis-a-vis QDBIAS and AMIRON.
