1. WE HAVE BEEN COORDINATING WITH LOCAL ^{FBI} [LNERGO] REP ON VARIOUS MHCHAOS MATTERS WHEN SUCH COORDINATION SPECIFICALLY AUTHORIZED BY HQS. IN MOST INSTANCES [LNERGO] REP HAS BEEN AWARE OF CASES AND HAS MADE APPROPRIATE ARRANGEMENTS [WITH] (S) TO AVOID DUPLICATION WE HAVE NOT DISCUSSED THESE CASES WITH [OUR CONTACTS].

2. INFORMATION REQUESTED BY HQS ON BEHALF ^{FBI} [LNERGO] IS DEVELOPED BY HONG KONG ^{FBI} [LNERGO] [FROM] (S) A CASE IN POINT IS SUSAN FRANK (HQS 6299). LOCAL [LNERGO] REP WELL AWARE OF FRANK [AND HAD ALERTED] (S) FRANK HAS NOW LEFT COLONY AND RETURNED TO U.S. ^{FBI} [LNERGO] REP HAS ADVISED ^{FBI} [LNERGO] HQS. AS A RULE LOCAL ^{FBI} [LNERGO] REP DOES NOT INFORM [STATION OF] (S) REPLIES ON VARIOUS MHCHAOS SUBJECTS. WE HAVE NOT TAKEN ISSUE WITH THIS PRACTICE SINCE IN THE CASES UNDER DISCUSSION INITIAL QUERIES CAME FROM ^{FBI} [LNERGO] HQS.

3. POINT WE WISH TO MAKE IS THAT LACK OF RESPONSE FROM [HONG KONG STATION] ON VARIOUS MHCHAOS SUBJECTS SHOULD NOT BE INTERPRETED AS LACK
