SUBJECT: World Council of Peace Planned Delegation to Paris

1. The following information has been provided by a sensitive and reliable source, who acquired it in late August 1969.

2. An undated memorandum in the possession of the French Communist Party entitled "Planned Delegation to Paris" indicated that the World Peace Council and the French Peace Movement want to bring to Paris, France, victims of United States fascism. The memorandum also makes the point that "now is the time to push for a ceasefire in Vietnam."

3. The following individuals were to be contacted to appear:

- a) Mrs. Martin Luther King
- b) Widow of Medger Evers
- c) Widow of Norman Morrisson
- d) Claire Johnson
- e) The mothers of the three civil rights workers killed in Mississippi. (Comment: The three civil rights workers referred to are probably Michael SCHWERNER, Andrew GOODMAN, and James CHANEY).

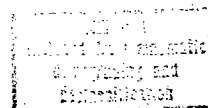
The memorandum said that Ethel KENNEDY had been approached but that she had declined to come.

Our records also reflect a Clarence M. JONES, mentioned in your Philadelphia memorandum of 5 September 1968, subject: Third National Conference on Black Power, as having attended the Conference.

7. Our records reflect one Alex ROSENBERG mentioned in your Seattle, Washington memorandum of 27 November 1968 subject: Hemispheric Conference to End the War in Vietnam, Montreal Quebec, Canada, as being a sponsor of the Conference.

8. Please furnish us with any additional information you may have on the individuals mentioned in paragraph four above.
