IN ADDITION TO LINERGO, SUBJECT: HAS PREVIOUSLY CONTACTED WOD ISH CHICAGO, WHICH WAS TOLD BY ITS HOS NOT TO CONTINUE THE RELATIONSHIP. HOWEVER, IN THE OFF CHARCE THAT THERE MAY BE SOME INTEREST, THE FOLLOWING IS FORWARDED.

A. MR. KHINER ALLEGES A CLOSE RELATIONSHIP WITH PRINCE NOR COOM SIHANOUK AND CLAIMS HE HAS BEEN INVITED TO MEET THE PRINCE DURING A FORTHCOMING TOUR OUT OF CHINA. HE HAS SUB-MITTED A NUMBER OF MIMEOGRAPHED NEWSLETTERS FROM THE GOVERNMENT IN EXILE WHICH INDICATE THAT HE IS AT LEAST ON THEIR MAILING LIST.

P. MR. KITTMER ALSO ALLEGES THAT HE HAS BEEN TOUD HE WILL BE ALLOWED TO OPEN A WORLD HAPPAS CORPUS OFFICE IN PEKING. ALTHOUGH THE CONNECTION BETWEEN THE TENETS OF THAT MOVEMENT AND THOSE OF THE DICTATORSHIP OF THE PROLETARIAT ARE NOT CLEAR. IN ANY EVENT HE ESTIMATES THE OFFICE COULD BE SET UP FOR \$250,000. IF WE WISH TO FIRMIGH THAT SHM, HE WOULD OPEN THE OFFICE FOR US AND ALLOW HS TO STAFF IT COMPLETELY WITH OUR OWN PEOPLE.
