1. AIR FORCE INTELLIGENCE ADVISES THAT MAJ. BERNARD F.

REHKOPF, USAF ASSIGNED TO MAQTHAI, HAS BEEN IN TOUCH ASKING ASSISTANCE IN CONTACTING AN LNERGO OFFICIAL. REHKOPF CLAIMS THAT HIS DAUGHTER RITA, WHO FORMERLY WORKED IN BANGKOK FOR LAW FIRM AND IS NOW BASED IN NEW ORLEANS WITH DELTA AIRLINES, HAS TELEPHONED HIM FROM NEW ORLEANS APPROX EIGHT TIMES IN LAST SEVERAL NIGHTS. SHE STATES SHE IS IN THE HANDS OF LNERGO. SHE CLAIMS THAT SHE KNEW JAMES EARL RAY AND SAYS SHE KNOWS HE WENT TO LONDON. SHE FURTHER CLAIMS THAT LNERGO IS PAYING FOR HER PHONE CALLS, AT THE SAME TIME IMPLYING, AT LEAST AS FAR AS REHKOPF IS CONCERNED, THAT SHE IS UNDER A CERTAIN AMOUNT OF DURESS.
