IT HAS JUST COME TO OUR ATTENTION THAT DOMESTIC CONTACT DIVISION {DCD} IN JANUARY 1974 INTERVIEWED STEPMEN VAN CLEAVE, PRESEDENT OF INTELLIGENCE SERVICES, LTD, A PRIVATE FIRM, ON HIS PREVIOUS TRIPS TO ARGENTINA. THE MEETING RESULTED FROM VAN CLEAVE'S REPEATED REQUESTS TO MEET WITH DCD REPRESENTATIVES. VAN CLEAVE'S INTERVIEW DESCRIBED MAINLY HIS ACTIVITIES IN ARGENTINA TO ORGANIZE A
- 2. DCD HAS BEEN BRIEFED ON FOTENTIAL PROBLEMS FOR STATION INHERENT IN VAN CLEAVE AND COUNCIL FOR THE AMERICAS INVOLVE-MENT WITH ARGENTINE FEDERAL POLICE ON MATTERS RELATED TO TERRORIST KIDNAPPINGS, AND IS ADVISING THEIR FIELD OFFICES TO AVOID CONTACT, WITH VAN CLEAVE IN FUTURE.
