IN ADDITION CLAIMED CIA ISSUED PASSPORT IN NAME MICHAEL JOSEPH M E R O L A FOR TRAVEL CENTRAL AMERICA.

2. PER HQS RECORDS, MEROLA NOT CIA AGENT, BUT HAS BEEN DCD CONTACT SINCE EARLY SIXTIES.
