1. DURING THE THIRD WEEK OF NOVEMBER 1963 DR. JACQUE FOURCAND, THE PERSONAL PHYSICIAN OF HAITIAN PRESIDENT FRANCOIS DUVALIER, ARRIVED THREE HOURS LATE AT A MEETING HE WAS TO HAVE WITH SEVERAL BUSINESSMEN IN PORT AU PRINCE. FOURCAND SAID HE WAS DELAYED BECAUSE HIS ASSISTANCE WAS REQUIRED IN TREATING DUVALIER WHO HAD SUFFERED A SLIGHT HEART SEIZURE THAT EVENING. (SOURCE COMMENT: FOURCAND IS THE ONLY PHYSICIAN PERMITTED TO ATTEND DUVALIER. HE IS AN ANTI-AMERICAN LEFTIST WHO IS REWARDED FOR HIS SERVICES TO DUVALIER BY PARTICIPATING IN BUSINESS VENTURES IN HAITI ON BEHALF OF DUVALIER WITH WHOM HE SHARES PROFITS ACCORDING TO DUVALIER'S REQUIREMENTS.)
