1. ⁰¹[DEGRIP] OUT OF TOWN AND UNAVAILABLE PAST WEEK, NARROWLY ESCAPED INJURY AUTO ACCIDENT WHILE TRYING REACH MEXI FOR SCHEDULED MEETING NIGHT 17 OCT. WAS MET MORNING 18 OCT AND PLANNED LEAVE SAME DAY FOR HAVANA ON TRIP ORDERED BY PARENT COMPANY WHICH RECENTLY RECEIVED INVITATION BID ON APPROX ONE MILLION DOLLAR PHARMACEUTICAL ORDER FOR GOC. ⁰¹[D] WAS DEBRIEFED AND BRIEFED ALONG LINES REFS AND PREVIOUSLY OUTSTANDING REQUIREMENTS.

2. SUBJ REF A OPERATES ⁰⁸["ITALFARMA" PHARMACEUTICAL LAB] HAVANA. BROTHER WAS REBEL ARMY CAPTAIN, FIRST NAME POSSIBLY ⁰⁶[AGUSTIN OR RAFAEL] ARRESTED TWO YEARS AGO FOR COUNTERREVOLUTIONARY ACTIVITY AND NOW SERVING 30 YEAR SENTENCE ISLE OF PINES PRISON. SUBJ HAS BEEN ARRESTED SEVERAL TIMES BUT SOON RELEASED. CONTACTS IN ARMED FORCES WERE APPARENTLY LIMITED TO ASSOCIATES OF ⁰⁸[BROTHER] WHO DID NOTHING TO HELP ⁰⁸[BROTHER] WHEN ON TRIAL. SUBJ IS ⁰⁸[BACHELOR, ABOUT 35] WAS

ACTIVE IN ANTI-PASTISTA CLANDESTINE ORGANIZATION OF CATHOLIC ORIENTATION LED BY (FNU) PASCO. [D] HAS NATURAL ACCESS AND WILL PROCEED WITH DEVELOPMENT, WILL INVESTIGATE EXTENT SUBJECT CONTACT WITH ACTUAL OR POTENTIAL DISSIDENTS IN ARMED FORCES. WILL LOOK INTO POSSIBILITIES EFFECT RECRUITMENT OF SUBJ WITH MINIMUM EXPOSURE.

3. REGARDING REPORT OF REF B, [DEGRIP] FEELS THIS MERELY DELAYED OFFICIAL ANNOUNCEMENT SINCE [ZOPILLA] MOVED FROM POST DEPUTY DIRECTOR MINISTRY OF [INDUSTRY] TO NEW POST OF CHIEF DEPARTMENT OF [ECONOMY] INRA SEVERAL MONTHS AGO. DOES NOT BELIEVE [ZOPILLA] HAS QUIT. WILL INVESTIGATE.

4. REGARDING REF C, [DEGRIP] SAYS [VALLEJO] IS ALSO CHIEF CASTRO BODYGUARD. [D] KNOWS GIRL NAMED [LAURA CEFERO] WHO KNOWS [VALLEJO]. [LAURA] WAS ARRESTED IN SANTA CLARA ALONG WITH SISTER AND TWO AUNTS WHO HAD HIDDEN IN THEIR HOME [THREE KUBARK AGENTS] WHO HAD RADIO XMT. [SISTER] WHO MAY HAVE BEEN MARRIED TO ONE OF KUBARK AGENTS, LATER ESCAPED. TWO AUNTS STILL IN PRISON. [LAURA] WAS RELEASED AFTER TWO YEARS IN JAIL THROUGH INTERCESSION [VALLEJO] AND IS SUPPOSEDLY STILL UNDER HIS PROTECTION. SHE RECENTLY TRIED GET JOB [DEGRIP] LABORATORY BUT REFUSED ASK FAVOR OF [VALLEJO] TO GET NECESSARY WORK PERMIT. SAYS SHE DID THIS BECAUSE SHE HAS OPPOSITE POLITICAL VIEWS. [LAURA] VERY CLOSE TO [ADOLFO REYES], ASSISTANT OF [D] IN HAVANA. [D] FEELS HE CAN APPROACH TO MEET [VALLEJO] THROUGH [LAURA] IN CONNECTION WITH GOO DESIRES TO PURCHASE [PHARMACEUTICALS] FROM [D] COMPANY. (WAVE: NOTE THAT WIFE OF SANTIAGO MIGUEL DOMINGO SANCHEZ DE LA TORRE WAS ARRESTED IN SANTA CLARA, 1961. KUBARK RADIO XMT FOUND, SHE LATER DEPARTED [CUBA]. COULD SHE BE SISTER OF [LAURA CEFERO]?)
