1. As a follow-up to our Reference memorandum, this is to advise that Kingston Station has queried SLHORIZON-1 again for further information on the subject of this memorandum. SLHORIZON-1 could provide no other facts regarding the Cuban Minister-Counselor's statement concerning the alleged role of Cuban exiles in the assassination of President Kennedy. SLHORIZON-1 does not know the identity of the Minister-Counselor's sub-source, although he had the impression that the allegations were based on a recent cable from the Cuban Ministry of Foreign Affairs.

2. A sanitized version of this memorandum and the Reference memorandum is now being prepared for the Office of the Legislative Counsel for passage to the House Select Committee on Assassinations.

3. The FBI has already been fully informed of the significant details in this matter.
