ON THESE OCCASIONS, OUR OFFICERS LISTENED TO V E C I A N A BUT EXPRESSED NO INTEREST IN AND OFFERED NO ENCOURAGE-MENT TO HIM AND NEVER RECONTACTED HIM ON THIS MATTER.
