- B. IN HIS TESTIMONY IN ENGLAND MR. ITKIN CLAIMED TO HAVE BEEN RECRUITED BY CIA IN AN "UNDDERCOVER CAPACITY" IN ABOUT 1954. HE CLAIMED HE WAS WITH THE C.I.A. UNTIL MARCH 1963 AT WHICH TIME BY SOME ARRANGEMENT HE WORKED FOR BOTH THE FBI AND CIA, UNTIL WARDARY 1965.
- C. MOFFITT ASKS FOR INFORMATION ON THE STATUS OF MR. ITKIN DURING THE YEARS 1964 TO 1969 AND FOR COPIES OF "ANY RELEVANT AFFIDAVITS OF PERSONS IN AUTHORITY IN THE FBI OR CIA USED IN PROCEEDINGS/IN USA."
- D. MOFFITT NOTED THAT IN THE INTERESTS OF PRIVACY HE ROUT-ED HIS LETTER VIA THE AUSTRALIAN-DIPLOMATIC POUCH, AND ASKED THAT THE REPLY BE RETURNED TO HIM BY THE AUSTRALIAN EMBASSY IN WASHINGTON.
- 2. MR. MOFFITT'S REQUEST WAS HANDLEDD BY THE OFFICE OF GENERAL COUNCIL (OGC) WHO MADE AVAILABLE FOR MR. MOFFITT COPIES OF THREE HAFFIDAVITS (ALL OF WHICH IN PUBLIC DOMAIN) RELEVANT TO HERBERT ITKIN I AND HIS AFFILIATION WITH THE CIA.
