## MEMORANDUM FOR THE RECORD

SUBJECT: HUNT, Everett Howard, Jr. OS #23500

- 1. On Wednesday, 6 February 1963, subject called to discuss a "personal" problem.
- 2. He said his wife planned to do translation work in her home for the Spanish Embassy. His question was: Does she have to register under the "Foreign Agents Registration Act." I told HUNT that this was a legal question for the OGC.
- 3. I then asked if he had gotten permission from OS for his wife to work for the (Spanish Embassy) He fuzzed the answer and said that his wife would go to work for the (Spanish Embassy) He gregardless of what he said-she was that independent. I told him he had better reconsider as he could get into trouble with us and DD/P. I suggested that he ask J. Bagnall if the JUSPB could use Mrs. Hunt to keep her from employment by the (Spanish 24) Embassy.) He liked the suggestion and would sound out Bagnall.
