1. (ESMICA-68) (E-68) PASSED (STATION) WRITTEN REPORT AND MADE VERBAL REPORT IN DETAIL, ALL WITH KNOWLEDGE OF PRESIDENT LAUGERUD, ON REF A CASE AND RESULTS. ACCORDING REPORT AND (E-68, NATIONAL LIBERATION MOVEMENT (MLN) WAS INVOLVED WITH JORGE ANTONIO "COKIE" ZIMERI SAFIE, WHO HAS BEEN LIVING MIAMI SINCE AUGUST 75, IN PLOT TO ASSASSINATE LAUGERUD. PLOT WAS TO HAVE BEEN CARRIED OUT 15 SEPTEMBER 75 BUT ZIMERI WAS VICTIM OF ATTACK ON HIS LIFE LATE AUGUST AND AS RESULT WENT TO MIAMI FOR MEDICAL TREATMENT. REPORT AND (E-68) CLAIM THAT TWO AMERICANS, BROTHERS ROBERT AND GERALD PATRICK HEMMING (NO (STATION) TRACES), WERE ALSO INVOLVED WITH ZIMERI IN PLOT AND THAT THEY ASSISTED HIM IN ACQUIRING ARMS, AMONG OTHER THINGS, WHICH FLOWN TO GUATEMALA ILLEGALLY IN SMALL AIRCRAFT.  SAID THAT HE HAD BEEN PROVIDING INFO TO GOG ON ZIMERI FOR PAST
 SIX MONTHS OR SO AND ADDED THAT TWO AMERICANS INVOLVED WITH
 ZIMERI, ONE OF WHOM RUNS A GUARD SERVICE IN MIAMI. HE DID
 NOT MENTION NAMES BUT DESCRIBED ONE AS ABOUT SIX FEET FOUR INCHES
 AND WEIGHING ABOUT 230 POUNDS. ⁰² (ESDEW-1 PLANS RETURN MIAMI WITHIN
