1. SENSITIVE SYMPATHIZER SOURCE INDICATES THAT ON 3 OCTOBER WILLEM OLTMAANS MADE APPOINTMENT MEET WITH CUBAN AMBASSADOR, THE HAGUE. OLTMAANS STATED HE GOING "TO AMERICA ON 18TH" AND THAT HE "IS INDEED PREPARED TO GO AT THE BEGINNING OF NOVEMBER AS ARRANGED".

2. DURING DISCUSSION, OLTMAANS SAID HE ALSO HAD VISIT SCHEDULED WITH RUSSIAN AMBASSADOR ROMANOV FOR 3 OCTOBER AND WANTED COMBINE TWO VISITS FOR SAME DAY. OLTMAANS WAS TOLD AN ATTEMPT BY CUBAN AMBASSADOR TO SCHEDULE MEET WITH HIM DURING WEEK 25 SEPTEMBER HAD BEEN UNSUCCESSFUL BECAUSE OLTMAANS COULD NOT BE REACHED. OLTMAANS STATED HE HAD BEEN IN SOVIET UNION THEN.

3. ABOVE EVIDENCE OF OLTMAN'S CONTINUING CLOSE CONTACT WITH CUBAN AND SOVIET DIPLOMATS AND HIS RECENT TRAVEL TO THE USSR AND APPARENT CURRENT TRAVEL TO CUBA
