Rodriguez<sup>03</sup>

Mr. ~~Rodriguez~~ has been a contract agent since April 1960. He was married to a U. S. citizen and was educated in the United States. He became a citizen by naturalization.

Initially, this agent was employed by the Havana Station where he served as a cutout to two principal agents. Having demonstrated his capabilities he was made principal agent for a staybehind net. When diplomatic relations between the U. S. and Cuba were broken, subject was on a vacation in the United States. He immediately left for Cuba to assume his duties, knowing that the risk was even greater now, but he was aware that his services at this point were very important. He arrived in Cuba the following day.

He was harassed numerous times and lived under continuous strain subject to arrest by the Cuban G-2. On four different occasions he was actually taken into custody by the Cuban authorities and questioned at some length. Despite this danger and risk he remained until June 1961 and did an outstanding job in the handling and reorganization of the staybehind net.
