REINALDO PADRON, A CLOSE ASSOCIATE OF ROGELIO CISNEROS DIAZ OF THE JUNTA REVOLUCIONARIA CUBANA (JURE, CUBAN REVOLUTIONARY JUNTA), SAID THAT CISNEROS PRESENTED HIS RESIGNATION FROM MEMBERSHIP IN JURE'S NATIONAL EXECUTIVE TO MANUEL RAY RIVERO ON 22 AUG 64. IN ADDITION, THE RESIGNATIONS OF MARIA ANTONIO GARCIA, SECRETARY OF ORGANIZATION OF THE FEMININE SECTION OF JURE'S MIAMI DELEGATION, AND JORGE ESTEVA VARELA, MIAMI DELEGATE, HAD BEEN PRESENTED TOGETHER WITH THAT OF CISNEROS.

PADRON THAT MANUEL VARELA CASTRO WOULD SUBMIT HIS RESIGNATION SHORTLY.

3. PADRON ASSERTED THAT THE RESIGNATIONS FROM JURE WERE MOTIVATED BY THE FACT THAT RAY FAILED TO KEEP HIS PROMISE TO BE IN CUBA BY 28 MAY 64.

4. (FIELD COMMENT: ANOTHER SOURCE WHO HAS REPORTED ACCURATELY FOR MORE THAN A YEAR ON EXILE POLITICAL DEVELOPMENTS IN GENERAL REPORTED THAT CISNEROS RESIGNED ON 22 AUG BECAUSE HE REALIZED THAT CERTAIN MEMBERS OF THE ORGANIZATION WERE DISSATISFIED WITH HIS LEADERSHIP.)
