1. IN ANSWER TO HQS QUERY IN REF PARA 3, AMCORE-2 SAYS THAT ONE MARIO (ALTUNA) WROTE HIM BACK IN 1961 OR 1962 AND ASKED AMCORE-2 TO SEND TAPES OF HIS PROGRAMS FOR REBROADCAST ON RADIO LIBERTAD. AMCORE BELIEVES THAT ALTUNA IS NO LONGER ASSOCIATED WITH THAT STATION. IN ADDITION, TWO REPRESENTATIVES OF RADIO LIBERTAD (IDENTITIES NOT RECALLED) CAME TO MIAMI AND SPOKE TO AMCORE-2 IN THE SAME CONNECTION. AMCORE-2 TOLD THEM AT THE TIME THAT HE WOULD BE PLEASED TO HAVE HIS PROGRAMS TRANSMITTED BY THEM, BUT HE VAGUELY REMEMBERS HAVING REFERRED THEM TO AMHIGH TO LAY ON THE NECESSARY ARRANGEMENTS. TO AMCORE-2'S KNOWLEDGE, NOTHING FURTHER EVER DEVELOPED.

2. AFTER RECEIPT OF RADIO LIBERTAD ADDRESS FROM CARACAS, AMCORE-2 WILL WRITE A LETTER ALONG LINES SUGGESTED REF. BELIEVE WE SHOULD AWAIT RADIO LIBERTAD'S REACTION TO AMCORE-2'S LETTER BEFORE HAVING AMSHADY-1 OR AMRAZOR-1 WRITE.
