- 1. REFERENCE IS MADE & TO OUR CSCI-316/01772-65 DATED 4 MAY 1965 CONCERNING SUBJECT. FURTHER INFORMATION RECEIVED BY A REPRESENTATIVE OF THIS AGENCY INDICATES THAT MOHRENSCHILDT INTENDS TO LEAVE HAITI FOR THE UNITED STATES TOWARDS THE END OF FEBRUARY OR EARLY MARCH 1966. SUBJECT STATED THAT HIS ORIGINAL CONTRACT WITH THE GOVERNMENT OF HAITI (GOH) ME HAD FALLEN THROUGH AND THAT THE GOH OWED HIM \$100,000. SUBJECT ADDED THAT HE PLANNED TO SPEND SIX WEEKS OR SO IN THE UNITED STATES AND THEN RETURN TO HAITI WITHOUT HIS WIFE TO TRY TO ARRANGE TO RECEIVE HIS BACK PAY IN THE FORM OF REAL ESTATE, PREFERABLY PROPERTY ON THE COAST WITH TOURIST/COMMERCIAL POTENTIAL.
- 2. MOHRENSCHILDT®S CLOSE CONTACT IN HAITI IS STILL WLODZIMIERZ GALICKI, THE POLISH COMMERCIAL REPRESENTATIVE IN HAITI. ONE HAITIAN MERCHANT ACCUSED GALICKI OF USING SUBJECT TO WIDEN HIS CONTACTS IN THE GOH. SUBJECT HAS ALSO BEEN ON CLOSE TERMS WITH NICOLAS I. ROUDE, A SUSPECTED SOVIET AGENT. SUBJECT AND HIS WIFE ARE GREGARIOUS AND HAVE MADE MANY CONTACTS IN HAITI.
