SUBJECT: Muhammad Abd-al Munim FAYID
Mohammed Abdel Moniem FAYID (English Spelling)

1. A reliable source has reported that a Mohamed FA'ID, who resides at the Waldorf Astoria Hotel (room 35), New York City, is negotiating an arms deal with President Francois DUVALIER of Haiti. FA'ID, who represents the General Commerce and Navigation Company of Lussit, maintains contact with George de MONTMANT, who is probably identical with the George de MONTMANT who was mentioned in the Warren Commission report. FA'ID in the past was involved with Rafael TRUJILLO, the late Dominican Republic dictator, and has been reported to have connections with Fidel CASTRO of Cuba.

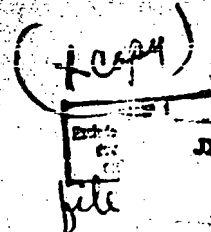
2. Subject is believed to be identical with Mohamed Abd-al Munim FAYID, who was born in Alexandria, Egypt, on 27 January 1929 and is described as follows: round face, dark curly hair, mustache covering upper lip, wears tinted glasses.

3. This Agency's representative in [Port-au-Prince, Haiti,] reported on 28 November 1964 that Muhammad Abd-al FAYID left Port-au-Prince on or about 28 November 1964 en route to Europe and the Near East. He was carrying Haitian Diplomatic Passport No. 1067. A former United Arab Republic citizen, FAYID became a naturalized Haitian citizen in November 1964.

4. In March 1953 it was reported from Saudi Arabia by a friendly Western service that Subject was a representative of the al-NASR Trading Company in Saudi Arabia, which was believed to be a cover firm for the Egyptian Intelligence Service. FAYID was described as a senior Egyptian Intelligence officer.
