SUBJECT

The Allegation by a Senior Cuben Diplomat Concerning the Role of Cuben Exiles in the Assassination of President Kennedy

According to a fairly reliable source, a senior Cuban diplomat stationed abread made certain charges in late September 1977 concerning the alleged role of Cuban exiles in the assassination of President John F. Kennedy. This diplosat made these allegations to his relleagues: in the course of an official meeting in his embassy. The diplomat said, among other things, that Cuban exiles such as ferner Cuban Air Force officer D i a s Lan (fau) and others had been involved in the assassination of a President Kennedy. The diplomat referred to the assassination in the context of a security lecture in which he claimed that counter-revolutionary activities by Cuban exiles have increased in recent nonths. He said that recent information had arrived implicating F i a z in the Kennedy assassination. The diplomat did not mention any other Cuban exiles by name or provide any further details? He did not identify the source of his information, although our source had the inprecision that the Pyle of while the tions were based on a recent cable from the Cuban Ministry of Foreign Affairs.
