- AMBANG-1 REFERED DURING 3/4 JULY MEETING WAVE AREA RYMENT ANSWERL-1 ACTION AGAINST JURE RADIO PACILITY. AMBARD-1 STATED AMSWIRL-1 ASSIGNED WAVE AREA SIPCE 56 OR 57 AND EX MACH. PRIEXD BATISTIANCS. WELLS ABBANG-1 REFIGRED AMSVIRL-1 REFUTATION AS BEIRG PRO-BATISTA, HE COMSIDERED THIS UNTEFORTANT AND NOT GERHAME TO ISSUE. THIS ASPECT RAISING ONLY WITH HATMAN.
- AMBANG-1 ALLEGES AMSTIRL-1 TOLD JURE REFS IN ROUSE AFTER MAKING REFERENCE "THE FAILURE" (AMBANG-1'S RECENT DETENTION) THAT MEN SHOULD NOT GIVE UP BUT GET RID THEIR LEADER AND CONTINUE FIGHT. AMBANG-1 FELT THAT SO HARM WOULD COME THIS STATEMENT GIVEN THAT MEN TO WHOM IT MADE "GOOD MEN." INTENT AND EFFECT OF SUCE A STATEMENT BY AN ODYOUR OPPICIAL DOES CONCERN AMBANG-1.
- 3. MAUHAN TOLD ANDANG-1 THAT AN ODYOKE OFFICIAL SCCH AS AMSWIRL-1 WOULD NECESCURILY DEVELOP INFORMATION FROM ALL TYPES INCLUDING BATISTIANOS. MAUNAN EXPRESSED DISBELIEF THAT AN ONTORE OFFICIAL, HAVING NOTHING TO POLITICAL POLICY, WOULD MAKE SUCH SECRET

ACTION ON WHAT IS FCC BUSINESS. NAUMAN STATED DID NOT KNOW

ALL LAW EMPORCEMENT AGENCIES.
