2. TAMAYO STATED THAT EACH REPORT FURNISHED WOULD PROVIDE SUFFICIENT PROOF PUT SUBJS THEREOF IN PRISON. OFFERED FOR 2,500 DOLLARS DOWN AND 2,500 DOLLARS AT TIME INFO VERIFIED TO REVEAL PERSON INSIDE CUBA FINANCING COUNTER REVOLUTION STATING 33 MILLION PESOS CAN BE SEIZED FROM THIS PERSON.
