1. SINCE REF B INSTRUCTIONS TO AMSPELL PASSED LACK FUNDS, AMSPELL MEMBERS HAVE BEEN SEARCHING OTHER SOURCES FUNDS FOR FJHEARSAY TRIP. AMSPELL CHIEF AMHINT-2 TOLD US CHILEAN CHRISTIAN DEMOCRAT GROUP MIGHT PROVIDE FUNDS AND HAVE FEW OTHER POSSIBILITIES. SUCH SUPPORT BY NO MEANS CERTAIN BUT WE MUST PREPARE FOR POSSIBILITY AND WE BELIEVE PREFERABLE GIVE KUBARK FUNDS TO HAVE ASSURANCE AMSPELL REP WOULD ACCEPT KUBARK DETAILED INSTRUCTIONS TO PREVENT FLAP. AMHINT-2 STATED REP WOULD FOLLOW KUBARK INSTRUCTIONS TO LETTER BUT THAT HE MUST SEND SOMEONE TO MEETING OR HE WILL HAVE EXTREME INTERNAL CRISIS AMSPELL ORGANIZATION.

2. WITHOUT LOGICAL EXPLANATIONS WE CANNOT DO MORE THAN GIVE BLUNT ORDER NOT SEND REP UNDER ANY CIRCUMSTANCES, WHICH WE AGREE WITH AMHINT-2 WOULD CAUSE SERIOUS CRISIS HIS GROUP (AND POSSIBLY NOT BE CARRIED OUT). ALSO WOULD CREATE CRISIS AMSPELL KUBARK RELATIONS WHICH SEEM BE MOVING TOWARD MORE REALISTIC COOPERATIVE BASIS WITH AMHINT-2 NOW IN CHARGE. REF A ARRIVED DURING TICKLISH PERIOD

INTERNAL AMSPELL REORGANIZATION UNDER AMHINT-2 AND ATTEMPTS BY  
 HAVE REDIRECT AMSPELL TOWARD SPECIALIZED TARGET ITS CUBAN COUNTER-  
 PART AND AWAY FROM GENERAL POLITICAL OPS. WHILE CUBA PRIMARY  
 TARGET, AMSPELL GROUP HAS ALWAYS ENGAGED INTERNATIONAL OPS SUCH AS  
 FJHEARSAY AND WOULD BE EXTREMELY DIFFICULT AMHINT-2 HOLD GROUP  
 TOGETHER IF ACTIVITY SUMMARILY CUT OFF AT TIME AMHINT-2 ORIENTING  
 GROUP TOWARD SPECIALIZED OPS AND AT DIFFICULT TIME INTERNAL REORGANIZATION
