Brown spoke on White America's exploitation of both the Negro and Filipino peoples, and stressed the need for "people's power", that is, the complete turnover to the people of all institutions that affect the people's lives. Finally, he concluded that the first step towards revolution is polarization, politicalization of communities, and the coordination of worker and student movements."


