- 2. According to source, the International Browns Committee, unlike the INC, pursues a well-defined political objective, namely to unite in a single organisation under United States patronage all democratic and enti-Communist refugees fleeing from the Soviet entellites. Source declare: that the leaders of the International Refugee Committee consider as truly desocratic only those refugees belonging to the peasant parties of Eastern Europe. Full support is given to these parties, or rather to their leaders such as Hikolajcay's for the Poles and (Dr.) Corps H. Committee for the Bulgarians. Assistance is denied to Paucists, forest Pascists and individuals who have profited under Commutation in their home countries. In the opinion of source, apart from the fact that it is not necessary to hold membership in a peasent party in order to be a true denormit, officials of the International Refugee Conciltee apparently wish to forget that Dr. Dimitrov is either unpopular or actually hated by large segments of the Bulgarian emigration. The supporters of Dimitrov ere nevely guests at the Jesi camp. Of the 163 Bulgarian emigros at this came, 150 belong to the Bulgarian Agrarian Party. Bulgarian refugees in other Italian camps and in unspecified semps in Germany, Austria and Switzerland are described as distinctly hostile to Dimitrov. The Bulgarian committee in France, headed by Nikola fielabency, enlists support for Dr. Dimitrov among Bulgarian emigres in that country.

SUBJECT: International Rescue Committee (INC); formerly International Rescue and Relief Committee (INC).

1. Reference is made to the request of Mr. Abujian on 15 December 1954 for information concerning the above ramed organization and individuals associated with the organization.

- 2. Dr. Bela GAMTAY, a feature major in the Royal Hungarian Police, substitud a document to the Department of State charging the INC and various members of the organization with futhering the interests of Communism under the guise of an anti-Communist relief organization. The files of this office contain no derogatory information on Bela GASTAY. His true mass is apparently Dr. Adalbert GANTAY, born 20 March 1910 in Budapest, hungary. A report of 22 Royander 1949 indicated that Subject had proviously been active. for a Western Intelligence group in activities directed against the Soviet Union.
- 3. According to a report of 30 March 1953, the International Rescue and Relief Committee (IRC) with offices at 103 Park Avenue, New York City and 35 Boulevard des Capacines, Paris, is an outgrowth of the former International Helief Committee and the Exergency Relief Committee. It was formed originally to assist refugees from Hazi Germany. Since 1945 it has functioned as an anti-Pascist organization assisting refugees without regard to nationality. It was stated in the report that the INNC, though not estensibly a Communist organization, had several Communists affiliated with it.
- 4. A reliable source reported on 15 March 1950 that one-third of the budget of the International Rescue Committee for 1948 and 1959 was expended in France in connection with Spaniards in exile, who were considerably penetrated by Communist influence. David MARTIH, described by Source as the principal force withing the IRC, was referred to as an ex-Trotakyite of considerable ability and energy.
- 5. It was stated in a report dated 20 March 1949 from a reliable source that since World War II, the IRC has come under suspicion as a possible

Consumist organization or elever front organization used by Communists for intelligence purposes. It was noted that in the United States and Europe the IRC maintained close contact with anti-Soviet emigra groups.

6. In summery, various allogations have been made against manhors of the IRC to the effect that they are Marxists, Communists or at least Socialists. Home of these proffered opinions can be substantiated; yet, it is plausible that the organization has been penetrated by Communist agents. The degree of control, if any, exercised by them cannot be determined from a review of the available material, nor can it be determined with certainty who in the organization are actually Communists. Attached hereto is available information concerning the following individuals montioned in CARTAY's report

SHOUNCE: INTERPARE NAL RESCUE COM FIRST (formerly International Rescue and Relief Committee)

- 1. The files of OSO/CIA reflect the following information on the International Rescue and Relief Committee (IRRC).
- 3. A report in Angust 1947 indicates that the IRRC of 103 Park Avenue, New York City, L.N. Wood, President, was an organization actively supporting the formation of international brigades for and providing other aids to the Greek partisans who were in rebellion against the loval government of Greece. Shela STRUISET was the official representative of this organization in Paris where an active branch of IRRC was located. The remort states further that one Dora MAPPIE, also a representative of IRRC, arrived in Paris (presumably from the United States) with a sum of money to be sment on recruitment for these international brigades. While in Paris, Norm MARTIN was in contact with a M. DEWNY, fru, reportedly a prominent Belgian Communist and an honorary colonel in the International Brigades, who, allegedly, came to Paris expressly to most her. After conversations with General JOINVILLE (real none Alfred MALLERET .- Communist Party deputy from the Seine), MARTIN left for southern France to inspect formations of international brigades. She was supposed to leave for morthern Italy with a representative of the Italian Communist Party sometime in late July 1947.
- 3. An except from a report from the Military Attache, Brussels dated 10 September 1947 stated that Dora MARTIN, as American and a delegate of the IMRC, was to contact the Branus intelligence service in France. Reportedly, she was accompanied by Jose GOSALMA MORTERA, a Soviet officer, who was a special agent of the "Control Intelligence Service." In addition, MARTIN was to contact the Spanish Republican Government and the clandestine forces in Spain, especially the members of the Basqua Resistance revenent. On the date of the report she was believed to be in Rilbao, Spain and allegedly was in possession of false identity papers in the name of Mercedes (last name illegible, possibly GOROSTUCUI).
- 4. In June 1948 it was reported that IERC had branch offices at via turors 31, Home, Italy, telephone 45980. IERC's American representative in Fone was listed as Frs. Edna LIST.
- 5. It is suggested that a further check be made at the Federal Eureau of Investigation on subject corporation, Shehn STRUMSNY and Edna LIST.

SPECIFIC- Report on Satellite nationals in the North German Area.

- 1. In 1945 the total number of refugees in West Germany amounted to 10 millions of people. By 1953 this number had been reduced to approximately 240,000, where it has remained relatively static ever since. Of this latter number, approximately 12,373 (or ca. 5 % of the total) were located in the Hamburg area. As a group, they are youthful and prolific. Approximately 12% are social cas s, 50% are active and employable adults, 8% are employed by the occupation authorities and over 25% are unemployed.
- 2. The overall percentage of non-German refugees among the native population is .48%. In Hamburg this figure is .73% while Schloswig-Holstein with the greatest concentration in Germany has a total number of refugees including German amounting to over 30% of the entire population.
- The national refugee groups in Hamburg as of 1 January 1953 were as follows:

Of this total of 12373 approximately 7000 may be considered active and employable and 5400 as non-active and unemployable. Of the 7000, 5000 are employed and 2000 unemployed. On this date they were located as follows in Hamburg:

It is interesting to compare the figure 2204 with the total for Hamburg refugee camps in Table A, 2189, and also with the figure in Table B, 2018 (17 February 1955) to show how static these figures are. (Table A: June 1952). Also of interest is the fact that the ratio of these in camps to those outside is generally 5:3 (Table A), while for Hamburg, the ratio is closer to 1:5. Of greatest interest to us of course are

the Czechs and Poles with the largest numbers. (This is not so clearly seen in Table A as the nationalities are listed only for Greek and Roman Catholics). The Russians will be watched, though small in number. Table B proves that most of the Czechs in this area are living on the economy.

4. The groups we are interested in arrived in West Germany as follows:

- 6. Table C for Niedersachsen is included to show that the statistics for 1952 given in Table A still apply. The total in 1952 of non-German refugees in Land Niedersachsen was 11,746. The figure on 1 January 1955 was 11,650, three years later.
- 7. To show why the German authorities tend to pay less attention to the non-German refugees, the figures for German refugees for Land Niedersachsen as of 1 August 1953 are included in Table D. (See also figures in 5 above.) If one includes those Germans receiving aid for losses resulting from the war, then the figure is 142,186 in 1623 camps as opposed to 11,746 in 28 camps for the Non-Germans.
- 8. Thus are efforts should properly be directed at those agencies primarily concerned with the Non-Cerman refugees. These are listed in Table E. Organizations involved in similar work in the United States are listed in Table F. By comparing E with F, we find a number of organizations of this nature without representation in Hamburg, and

thereby affording possible cover for our purposes. Of those organizations listed in Table E, Staples has met the representatives of 7, 10 and 12 to date.

- 9. A further group active among the non-German refugees is the Union of Polith Refugees in Germany, 22s, Velbert, Enineland, Schliessfach 291. Staples as met the Freside t and Secretary General of this organization, Kazimier DROBNY and Witol JWA SICC, as well as the Vice Chairman of District 1 (Hamburg), Stanisla: INCLUR.
- 10. Very generally, we can say that cur refugee in this area is a youthful Pole who arrived in Germany ca. 1945. He is unemployed or has a low-paying job, and is living on the economy with little or no chance of bettering his position here in Germany. He probably has family responsibilities. The authorities do not pay much attention to him, owing to the assimitude of the increasing German refugee problem. Nevertheless he is in contact with representatives either or both of the power blocs in Europe, each of which is attempting to win his support. He is not suited for espionage save in very low-level operations. On the other hand, he most likely would enter such work only if promised long term solutions to his present problems.

Report on Russian Refugees & Facarese

In Vestern Germany and Austria today there are thousands of Soviet nationals who either succeeded in escaping the attention of the E.V.D. at the end of the war or else had made their way through the Iron Curtain since that time. Many of these are persons of the highest caliber, some of international reputation. They ask nothing more of the democracies than the opportunity to offer their services in the struggle against Soviet totalitarisms.

Unfortunately there exists among these refugees a wide-spread fear of detection by local communists or N.V.D. agents. Because of IRRC's long established reputation as an organization upon which anti-totelitarian refugees may rely; many refugees who had such hesitations about approaching the occupation authorities, have come to IRRC to ask its assistance.

The paragraphs that follow briefly describe the cases of four typical Soviet refugees.

VIAPILIP, PPAHOUSKI

Viadiair Brailowsky was one of the Soviet Union's foremost physicists. He was associated with the nuclear imboratory of the Physical Technical Institute at Kharkov from 1932 to 1942, and for the last two years of his association he was the Senior Scientific Forker of the Institute. From 1935 to 1941, he was also chief of the Physics Department of the Institute of Fedical Research. He is the author of a number of works on nuclear physics, in Russian and French.

Deported to Germany in 1943, he worked as a slave laborar until the liberation. Although he was one of the men the Soviets were most anxious to recover, he refused to return and succeeded in cluding the E.V.D. agents.

PAUL ITSSENKO

Dr. Iyaserko is the brother of the famous Soviet academician of the same name. A chemist of national repute in the Soviet Union, Iyaserko was on the staff of the Scientific Experimental Institute in Kharkev from 1932 to 1942 and is the author of over thirty scientific works in the field of coke chemistry. Deported to Germany as a slave-laborer in 1942, he and his wife refused to return to Fussia when the war was over, even though they could have enjoyed positions of high injertance there. Despite the many restrictions and hardships that he encountered as a D.P., he worked out a nevel method for the extraction of syrup and sloobel from chestmits

and obtained permission to open a small fectory. The quality of his products has been highly consended by conservent quarters. Dr. Lyssenko has also developed and tested a method which, he reports, could result in the utilization of 40-50% of the currently unused by-products of the American coke industry.

LTC KASFINKO

Br. Kerrenko is a Ukrainian civil engineer who is at present employed as an instructor at the Garmisch Intelligence School of C.I.C. In addition to being a qualified engineer he has taken a degree in Philology and he has also worked as a miniaturist and as the art director of the Toy Factory. In the Soviet Union, due to the fact that he belonged to a "socially alien class" he was deprived of his electoral rights and, therefore, did not serve in the army. He was forcibly evacuated by the Germans in 1944. Ris application for visa has been backed by C.I.C.

GEFGORIJ PODOLAK

Professor Fodolsk is a Ukrainian writer and literary critic of note who has spent time in both Bolshevik and Nami prisons. In 1927 - *28 he was a member of the editorial staff of the important Ukrainian magazine VAPOLITE, which had concentrated around it a strong literary humanistic movement. The group enjoyed only a brief period of relative freedom, until it was ruthlessly destroyed by the deportation or execution of all its leading members. The movement experienced a resurgence during the war and fought against the Nazis on the one hand and the Stalinists on the other, suffering terrible persecution from both, losing many of its members through torture or suicide.

Professor Podolak was deported to Germany as a slave laborer in 1943. In a note written about himself he said, "By profession I am, 1) a weaver, 2) a veretable gardener, 3) a housecleaner, dishwasher, janitor, and unskilled laborer." He has been highly recommended by David Dallin and approved by C.I.C.

Here are men who not only are extremely capable in specialized fields but -- what is more important -- who can vastly expand our understanding of the Soviet Union and the Soviet mentality. They are men who have a great contribution to make to the western democracies and who are more than eager to serve them. But so far they have been probably less favored than any other group of refugees. For the most part they continue to lead a difficult and precarious existence, continually hunted by Soviet agents. Kidnappings, "suicides", disappearances, etc., occur constantly and such acts are often assisted by local communist organizations.

There government agencies are frequently unable to act, a private agency unencumbered by government red tage, is in a position to do much. The IRRC believes that it is particularly qualified to deal with this problem because of its long experience in assisting anti-totaliterian refugees and because of the very careful selection of its field staff. In the case of the

Soviet refugees at present in Europe, both huranity and national selfinterest dictate that this assistance be given as soon as possible. In concrete terms this means in the first place, providing these refugees with food and clothing and medical care and counsel; in the second place, it means providing them with haven in the United States or one of the other western democracies.





The German Social Democracy and been bunning to for years before Mitter's accession to power. His appointment to the chancellorship of the Neich by the senile President von Mindenburg was simply the official recognition of a fact generally known for some time.

Two main reasons brought about the breakdown of the Social Democratic Party. First, the spiritual and tactical weakness of the once proud militant party of August bebel and Wilhelm Liebkmecht. Secondly, the treacherous tactics of the Moscow-directed Communist Party which, through its flirtation and active cooperation with the National Socialist Party, expected to fall heir to whatever would be left of the Social Democracy. It is history now that Mitler harvested the fruit of Moscow's va banque policy.

In the fall of 1933 a pamphlet "Now Beginning - Fascism or Socialism" was published in Karlsbad, Gzochoslovakia. Its author "Miles" condemned the German Social Democratic Party and particularly its leadership severely, demanding a sharp turn to the Left if Socialism should survive this crisis.

beyonal months before Mitler's coming to power certain Leftists within the Social Democratic Party had met secretly in Berlin, organizing a group which was to gain recruits in the more important cities and industrial districts for a Left Wing of the Social Democratic Party. It was the intention of those New Beginners, as they called themselves, to work within the framework of the old party, trying to force a more

radical policy on the S.D.P.

The Manifesto of the New Beginners group contained, what it called the central thought of the movement. We find it reproduced in the Hiles pamphlet:

".. Marxism alone is the key to the Socialist transformation of the world," it read. "The Socialism that is to come will be nothing if not Marxist...It is not the Marxism of the Socialist parties that has failed; it is rather the Socialist parties that have failed because they have not been Marxist enough. The more firmly the Socialist parties base their theory and practice on Marxism, the more easily, the more rapidly and the more certainly will they accomplish the great tasks which history has laid on them.."

Eighteen months before the organization of the New Beginners, another Social Democratic secession had taken place - the Socialistische Arbeiter-Partei (Socialist Labor Party). This party placed the same emphasis on Marxism as being the life blood of Socialist practice. But the S.L.P. had failed miserably. Marxism did not save the New Beginning groups either. They both remained anemic plants, unable to live and still less able to die.

"Miles", the author of the first New Beginners pamphlet, was Dr. Karl Frank who had served as lieutenant in an Austrian artillery regiment during the World War. From the army he went straight to Munich, participated in the Bavarian Soviet government and from there to Berlin, where he joined the Spartakus Bund and a few months later became a charter member

of the Communist Party of Gormany.

Hore he advanced quickly. The German Communist Party had fow intellectuals in its ranks and Frank, who had been writing in the "lener "Arboiter-Zeltung" before he joined the army became almost impediately a member of the staff of the "Rote Falme", the official party organ. In 1924 he was appointed editor of the "Rote Fahno" and was regarded as the confidential man of the Comintern, the executive body of the Communist International. He remained with the Communist Party until the beginning of 1931, left it to join the (Right Wing) Brandler-Thalhelmer Communist opposition group, and went from there into the Social Democratic Party, where he was responsible for the organization of the New Beginners groups. People who are familiar with the inner workings of the Comintern and who have known Frank since 1919 insist that he always has been employed by the Communist International, that he was also a C.P.U. man. They also insist that he is still in the employ of the inner circle of the Communist International.

I met him first in Vienna in October 1933, when he called me up at my hotel and expressed the wish to discuss important party matters with me. He came to me under the name of G. Mueller, and we discussed the organizational possibilities of the "New Beginning". He promised to send me material to New York which some time later enabled me to write an article on the new movement for the New Republic, which was published there in July, 1934.

Later I met him on and off in New York on his trips to

collect funds for his group and for underground work in great was group. With the aid of the League for Industrial wemocracy and its Secretary, Mrs. Mary Fox (at whose apartment he lived), who introduced him to the large circle of well-to-do unattached ladies here (Frank is a great ladies' man) he collected relatively large sums. These ladies, all anxious to "do something for the cause" arranged dozens of luncheons and suppers for him and he could truthfully boast of his great success.

There have been all sorts of accusations against him for alleged misuso of these funds, for the lack of control and audit of these funds, etc. (by an M.P. of the British Labor Party, by the Jewish Daily Forward and the Neue Volkazeitung, etc. etc., but his friends here — Professor Reinhold Niebuhr and other leading members of the League for Industrial Democracy stood and stand by him and vouch for his intellectual and physical integrity. As far as I know, his group does not control any, not even a small, organization in Germany and recent newcomers from Europe assure me that there never was any group worth mentioning connected with the Frank organization which did underground work. They say that Dr. Prank — who lives in the United States under the name of Paul Hagen — and the stories he tells at private and semi-public meetings, are 90% bluff.

The "Inside Germany" reports which are issued in Dr. Niobuhr's name, are edited by Dr. Frank. I was present at a

dinner of Dr. Mieburr's group last winter in support of "Inside Germany" at which he was eulogized as the man who is responsible "for the existence of a net of radical underground organizations in the Third Reich which finally will be the lever to overthrow Mazi tyranny". This and similar twaddle has been circulated all over the United States and there are many who really believe it. That Dr. Miebuhr should be so easily taken in passes my comprehension. That he knowingly makes use of a "false alarm" I am most reluctant to believe.

More recently Frank-Hagen has been helpful in bringing in Stalinists into the United States and keeping anti-Stalinist radicals out. This has been made possible by his close association with Miss Warburg (now Mrs. Spinelli) and his cooperation with her work for the "Emergency Rescue Committee", nominally directed by Dr. Frank Kingdon. This organization was merged recently with the "International Relief Organization", directed by Miss Strunsky, as the "International Rescue Relief Committee". Several such cases have come to my attention and they strengthen the opinion of those who know that he is still working for the Comintern or for some one of its sub-divisions. One former Communist who held a very prominent position in the European Communist movement holds to the firm conviction that all of Frank's party wanderings inside and outside of the Communist Party were under direct orders from "above". Whether this is true or not, I, of course, can only speculate. That sort of thing defies proof.

I remember once asking Mrs. Pfister about her relationship to the Neuca Parinnan, and I do not remember that I had any very satisfactory answer.

REPORT ON THE RUSSIAN RETUGEE

1. In compliance with a directive of IRC's Executive Committee I spent the week of January 21 through January 25 in Rome in order to assist our Rome office in overcoming the complex organizational difficulties created by the sudden appearance of 200 Russian Jews from Israel who, during the first ten days of January, had applied for help and resettlement services. With this mass intake, as it were, our Russian caseload in Italy -- including a handful of non-Jewish emigres and a dozen or so mixed families who had come to Rome from Vienna - had shot up to 605 people belonging to 262 family units. This was the overall registration figure by the middle of January.

The problem had its origin in the September 9 decision of the United HIAS Service and the Joint Distribution Cormittee not to provide further financial aid and resettlement to Russians arriving in Rome from Israel. When HIAS-Rone was unable to accept them, they turned to IRC. We could not turn them down. Somebody had to help them.

Prior to the year-end influx, 92 Russian Jewish refugees processed by our Rome office had left for the United States or, in a very few instances, for other destinations. For a minority of them, resettlement in the United States was handled by ourselves with the backing of the ACJ Philanthropic Fund. The vest majority, however, were accepted by local Jewish Family Services and the New York Association for New Americans (NYANA) through the good offices of HIAS-New York.

2. The chaotic situation brought about by the pressure of a large and compact group of refugees almost broke the back of our small staff and disrupted our limited facilities in Rome. As a rule, refugees are placed in refugee camps in Italy, and our headquarters ser-up. consisting of only three people operating out of a three-room office. was utterly inadequate to cope with 80 to 100 people who presented themselves each day with a hyriad of individual needs. Threatened with eviction, we rented space in one of the beareant bouses open to refugees. But these premises had to be vacated them masses of people blocked the street and the staircases of the building where our workers were trying to listen to their requests. Temporary quarters were found in the hostel of the Salvanion Army. Then we were asked to leave the hostel, We moved, on January 23, to a hall inside the main railined station

of nome which is used by the Migration Department of the Italian Ministry of Labor for the processing of Italian workers signed up for employment schemes abroad, and by the Intergovernmental Committee for European Migration (ICEN) as a collection point whenever there is an ICEN flight. As of rebruary 21 we are still working out of this area, unsuitable as it is, since nore permanent and more suitable space could not be located. It is uncertain how long we will be permitted to remain there.

3. Carret Ackerson, our European Director, (Caynor Jacobson, the Executive Vice President of HIAS, and also the Director of the HIAS-Ceneva office came to Roma while I was there. It was Carret Ackerson who had alerted us to the untenable conditions he had witnessed in Roma during his previous visit and to the unconscionable burden we had placed on our representatives, Rade and Violet Korach, whose sterling performance was a bright chapter in what otherwise is a disturbing story.

The IRC staff was expanded to seven people during my stay in Italy. Unrelated to my presence was another development which enabled us to bring a modicum of order into the chaos that had prevailed during the first two weeks of January -- the unexpected stop in the flow of neverners which occurred on January 17. On that day we learned that Italy had ceased issuing visas to Russians trying to leave Israel. Instead, all applicants were told that their requests would be referred to the Ministry of Foreign Affairs. As of the writing of this report, only about a dozen new cases have reached Italy. We have not been informed of the selection criteria. if any, which led to the issuance of their visas by the Italian Consulate in Israel. In any event, by the middle of Tebruary our overall Russian caseload had risen from 600 to about 630, of whom about 170 had left for the United States or, some, for other places. This means that as of now roughly 450 are being taken care of by IRC-Rome. All but about 100 of then appear to be eligible for admission to the United States and. hopefully, will come here soon.

4. The natter of eligibility for V.S. immigration hinges on the type of passport these people have. Newconers to Israel who are absorbed under the Law of Return are given light blue passports, marked "Laissez Passer," if they leave Israel within one year of their arrival. They are considered admissible to the United States under the special parole program approved by the Attorney Ceneral last year. Those who remain longer than one year are issued dark blue passports, the same as are given to any other citizen of Israel. Dearers of these passports have been ruled ineligible under the religible provisions of our immigration statues, presumably because the color or the passport denotes firm resettlement in Israel.

This distinction cannot be substantiated. If anything, the light blue passport may indicate a greater degree of economic adjustment than the dark bur pausort. In order to obtain travel documents, the nowcomer from Fiscial hus to repay some expenditures the Jewish Agency incurred in his mosettlement. He also has to scrape together enough noney to buy his plane ticke to Rome. People who have been unemployed for any length of time, or who are been undercaployed, are less able to acquit themselves of this financial appointability. It's likely to take them more than one year to reach the armired level of mobility, or that's what I was told again and again by a see who hold passports of the darker hue. least seven years. Why should be insist that in another setting it invariably takes only one year and one day to shed one's resugge identity? A technical, narrow approach is no answer to an unressived human problem. And one wishes this simple truth were recognized not only by the United States Sefucee Program (USAP) without whose generous understanding the shole relief operation in Some would have collapsed long ago.

- 7. Since returning from Italy I have been troubled by the apprehension that a loss of hope resulting from a lack of compassion hight create a psychology of desperation which could lead some of the people in Robe to ask for repatriation to the Soviet Union. To permit things to deteriorate to this point would be a grave disservice not only to Soviet Jevry but to all other nationalities the are trying to emulate the Jevish example and are beginning to claim their right to leave Russia. That's way it would be so important that the major Jevish organizations reactivate their involvement with this small group out of Israel; that's way we will have to reason with the Immigration and Naturalization Service when it denies refugee status to passport holders; and that's way it would be important that other outlets be opened up in countries like Canada and perhaps Australia and New Zealand.
- 8. I did not try to talk to the Russian returnees from Israel who are now living in Victua's Malagasse waiting for permission to go back to Russia. On November 20, 1973, of the 237 people in this group 193 were still in-Austria. Twenty-one had been accepted by the Soviet Union, nine had gone to other countries, six returned to Israel and three had died. As for the continuing movements of Russian Jews through Austria, the figures were particularly high during the last three months of 1973 bringing their total well above the 20,000 level for the entire year. The arrival rate dropped in January to about 2,200 of whom, I was told, about 65 did not go on to Israel but requested help to go to other countries, mainly the United States. They were sent on to Rome where MLLS runs an exemplary resettlement program. It is to be hoped that the improved counseling now available in Austria will reduce the number of those who proceed to Israel without being firmly decided to stay in Israel and make a go of it.
- 9. While I was in Rome, the Italian press echoed the oil-related overtures of the Italian government to several Arab countries. There has also been a recrudescence of anti-Semitic outpourings. An unvariable, primitive explosive device of sorts was deposited in the ICEM work area the space we occupy now at the FR Station, and several voluntary agencies, including the IRC, received anti-Semitic press clippings in the mail. These things can and do hoppen elsewhere. But I could not free myself from the impression that Rome is an unhealthy place for large groups of Jewish refuge who have nowhere to go. For those who can come to the United States, speedy acceptance by the Jewish Family Services and NEAM would be of great help. Their "transit" in Rome should not attracted out beyond the absolute minimum into a stay of indefinite duration.

SUBJECT:

International Rescue Committee

1. The International Rescue Committee is a relief organisation which has administered aid to political victims of totalitarian persecution since 1933, for the most part victims of Nazi, Fascist, and Communist persecution. Whereas in the years prior to and during the war most of the recipients of its aid were anti-Nazis, it has never rendered aid to Communists or Fellow Travellers simply because they qualified as anti-Nazis.

Since 1945 when the victims of Razi persecution either returned to their homelands or were cared for by other organizations, the International Rescue Committee has devoted most of its attention to Stalinist persecutees.

2. The International Rescue Committee is a private organization. Attached hereto are specimens of descriptive literature showing the names of its sponsors and the type of appeal it makes to the American public. It is currently engaged in a nation-wide fund-raising drive in the United States under the banner of THE IRON CURTON REFUGEE CAMPAIGN.

During 1949 the Committee raised through private channels approximately \$400,000. During the same period it received a grant from I.R.O. of approximately \$725,000. The funds available to it, therefore, were approximately \$1,125,000. Overheads are kept to a minimum, and the total of fund-raising costs and administrative expenditures are kept below 10 per cent. of the total revenue.

3. The work of the Committee consists in helping escapees from behind the Iron Curtain. The Committee maintains offices in Turkey, Austria, Germany, Italy, Sweden, and France. The nature of the aid rendered varies according to circumstance. Persons crossing into the free zones from behind the Curtain who find their way to the Committee's premises may receive small money grants, CARE packages, or clothes depending upon their most immediate needs.

The Committee then attempts to obtain some kind of legal status for these persons through the Occupation Authorities. In Italy, Turkey, Sweden, and France, of course, this problem does not arise.

The Committee concerns itself only with those escapees who show evidence of any genuine belief in democracy. This general statement, of course, requires more amplification than this short memorandum can carry. What is meant briefly is that the Committee does not render aid to former Iron Guardists and persons of similar political stripe in other satellite countries. In the case of Soviet exiles a "genuine belief in democracy" is hard to determine, and as a general rule all Soviet escapees. are aided.

Since the war the International Rescue Committee has succeeded in bringing to the United States some of the most prominent leaders of the Democratic movements of Eastern Europe and the Balkans. Among these can be numbered Dimitrov, former leader of the Agrarian Peasant Party in Bulgaria; also prominent Peasant leaders, Social Democrats, and Christian Democrats from Hungary, Poland, Roumania, and the Baltic countries.

The Committee also brought to the United States
Pavlo. D. Lysenko, brother of the famous Soviet geneticist,
and in his own right the leading coal chemist of the Soviet
Union who directed all of the coal research in the Donets
Basin. Fany other persons of great potential value to the
United States have been brought to the United States, and
large numbers of others are currently being cared for in
Western Europe, among whom for instance is one of the leading
Soviet cartographers whom the Committee has so far been unable
to bring to the United States.

4. Among other important persons whom the Committee has rescued in Europe can be numbered Ernst Reuther who was found in hiding in Turkey in 1944 and whom the Committee rushed to Berlin as soon as that city was occupied. The courage of Ernst Routher was perhaps decisive in rallying the population of Western Berlin against Soviet threats.

Another person rescued by the Committee was line.

Soviet Slave Camps startled the world. Nme. Neumann was found in Ravensbruk Concentration Camp by advance Allied troops. The Cormittee took her to Sweden where she under-went a long convalescence. The above examples are marely illustrative. Hundreds of people are daily making contact with the Committee's representatives in Western Europe. Among these may be found representatives of the intellectual and scientific leadership of Eastern Europe whose potential value to the United States cannot be measured. The writer earnestly believes that this work is of the highest national importance to our country and should be expanded.

5. At the present time the major portion of the funds available to the Committee has been cut off. In anticipation of the closing of I.R.O., the financial grants which the Committee formarly received have now ceased. This means a loss of \$725,000, which threatens to reduce the Organization's activities by approximately 60 per cent. Such a course is unthinkable. The Committee is redoubling its private fundamental for the deficiency. But it must be recognized that in spite of such efforts, it is doubtful whether private fund-raising will yield more than approximately \$400,000 to \$500,000, which is about the maximum quantity that an organization of this kind can raise.

With the funds available to the Committee during 1949 it was possible to do no more than scratch the surface of this vast problem. The need is so far greater than the availability that three or four times this amount would perhaps not be adequate. It is, however, vital that the Committee be not obliged to reduce its activities. Consequently it is urged that assistance from other sources be obtained at the very least to compensate for the loss of I. R. O. support.
