If you are really that powerful, who are you enyway and what are your real duties here in Finland? This unexpected answer allegedly disturbed COLUB sufficiently that the subject was pursued no further.
- 2. WHE's cuestion is interesting in view of the BODENING operation. We are trying to find out the exact date of the conversation.
- 3. COLUE has overtly the function of Consul. In that slot he succeeded Ivan Yefimovich SECLIEV, a known RIS officer identified by ABIPPIR/19. [VACCINE/1] [O] also said on Li October that Ivan SHISHKIN, also a known RIS officer (e.g., VINCUISHER case) will be leaving Finland PCS in the week of 21-27 October 1957. This makes the second RIS case officer to leave Finland FCS in October 1957. COLUE himself left Finland with his family in early September and has not yet come back. Ivan VORDERIV left with family on 1 October 1957.
