

On 25 Feb 63, PARMESE and I picked up (LIAINTL-9) at rendezvous point and we drove to a barrio area of the city where meeting was held. NO SECURITY INCUBUS NOTED. Item: 2170-2245

(LIAINTL-9) provided the following info:

1. Irina TRAFOTE de VALDES, wife of Ramiro VALDES, Sec Gobernacion in Habana is scheduled to leave for Habana on 1 Mar 63.

261-3342 Cubans in the Cubana plane on 25 Feb that he has been in Prague on two occasions. ~~per FEB 63~~

3. ~~Magdalena GARCIA, Mexican wife of Humberto GARCIA told (L-9)~~ of ~~CITY OF MEXICO, MEXICO CITY~~
on the phone that Antonio "Nicol" GARCIA had a message for her.

(L-9) queried GARCIA re same and GARCIA told (L-9) that he did not have a message from anybody for Magdalena GARCIA.

4. On 25 Feb 63, (L-9) said that two valijas left Mexico for Habana. He said that the lightest one carried confidential reports. He said that Ramirez put two confidential reports in the pouch in his presence. ~~CITY OF MEXICO, MEXICO CITY~~

5. (L-9) said that Pilar, mu, stewardess and two others were arrested and sent to a farm formerly owned by BATISTI where they will spend from 1-2 years. The three were charged with contraband operations on HAVA-MEXI flight. According to the report, 10,000 dollars worth of jewels were found in the back of a plane seat which returned to Havana from Mexico. It appears that the jewels were not taken off the plane in Mexico as planned.

6. (Dr) Angel MARTINEZ Orando, Mexican biochemist, left Mexico for Habana on 25 Feb 63. MARTINEZ told (L-9) that he hoped to be named honorary Consul in Santiago de Cuba where a Spaniard is currently holding the job. According to MARTINEZ, the Spaniard is not in the Gov't's good graces and he hopes to replace him.

7. (L-9)^o has heard nothing of importance re MONTAGU visit from Cuban dips. On 25 Feb the following group had coffee on board the Cubana plane: Antonio "Nico" GARCIA, Manuel VILLALBA PEREZ, ~~INVESTIGATOR~~ Eusebio AZCUE Lopez, Eneigno CASTELLAR Sanchez, Andres ARROYO Rios and (L-9)^o. The group was very angry because of the new stamp that the Cuban Gov't is using at the airport. All passports are now being stamped by Immigration officials as follows: SALIO A CUBA or LLEGÓ DE CUBA. This stamp is placed on the page where the subjects photo is found. The group said that as soon as the Ambassador arrives he should speak loudly to the Mexican Govt about this.

9. On 25 February 1963, Cotr. SOLORZANO, sister in law of Crnl Lazaro CARDENAS called RAMON SUCUMBOS CAVAZOS "un perdedorillo incorregible". SOLORZANO is the god-mother to one of SUCUMBOS' children. SOLORZANO also remarked that Julio ARGUELLES, who is a partner of Cuauhtemoc CARDENAS, cannot understand what is the matter with the Cuban Govt letting the Embassy "go to pot", i.e. lack of personnel deciente y adecuado. Subject: (LITHAIL-9) 01

On 22 Feb 63, I met (LITHAIL-9) at rendezvous point and we drove to darkened street behind my home, where we held mtg. NO SECURITY PROBLEMS NOTED. Time: 2200-2300. (L-9) and I then went to my house where we talked at great length with PARTERS re (L-9)'s assignment.

(L-9) provided the following information:

1. On 21 Feb 63, (L-9) attended the inauguration of Exposition at the Bellas Artes. Pres LOPEZ Mateos also in attendance. (L-9) saw ~~SEXY~~ ^{CIT. MEXICO} ~~SEXY~~ ⁰¹ HENESTROZA and Dolores DE LA MORA Zerada also. (L-9) told DE LA MORA ^{FEB} he was returning to Cuba and would be happy to take a letter with him for her. At 1645 (L-9) visited DE LA MORA at her home. DE LA MORA told (L-9) that she was very worried about Cuba, i.e. with the recall of Soviet troops, arrival of BUSTAMANTE in Mexico etc. She said that she told PRESIDENTE ^{Justo Sierra} ~~DE LA MORA~~ ^{RE (LITHAIL-9) REPORT ON SOVIET} Mexican to tell Pres. LOPEZ Mateos that she not proud of being a Mexican because-of-the-Gov'ts anti-Castro attitude. She cited the activities at the airport as an example. She told DE LA MORA to tell LOPEZ that "la barrera que te rodea te impide conocer la verdad". DE LA MORA told (L-9) that she saw LOPEZ Mateos after this and he said that following to her in a sarcastic manner: "Te felicito... no eres Mexicana", (Fidel) Tu amigo "pelele", no lo tuvieron EN MEXICO presente pasada crisis, mientras Mexico sosteniendo principio "no intervencion".

DE LA MORA said that her father will accompany her son Lopez Mateos on his trip to Europe. DE LA MORA told (L-9) that Sen. MORENO Sanchez considers it very important that Cuba have an
