MEMORANDUM OF ORAL COMMITMENT

TO : Chief, Special Affairs Staff

FROM : Chief of Station, JMWAVE

SUBJECT: Engagement of Miguel DIAZ Isalgua 201-307337

1. Tern and Project Charge. The Subject individual has been engaged under oral contract for use under TYPIC and is to be charged against PM cost center. The effective date of the oral contract is 16 September 1963 and it shall continue until terminated by either party upon fifteen days actual notice.

2. Security Approval. The appropriate security approval to utilize Subject as requested has been obtained. OA granted 6 February 1963 via DIR-18422

3. Citizenship. The Subject is a Cuban national and was born on 14 February 1937 at Matanzas, Cuba and resides at 1343 N. E. Miami Ct., Apt. 17, Miami 32, Florida.

4. Compensation. Commencing on the effective date of this agreement, Subject will be paid compensation at the rate of \$395.64 per month. Such payments to be made following completion of satisfactory service. Payments will be made on a semi-monthly basis to the Subject's wife through New York cover firm per WAVE-6133, 21 March 63.

5. Taxes. Subject will XXXXXXX be obligated to pay U.S. income tax. Taxes will XXXXXXX be deducted from the above stated paid compensation. Subject is XXXXXXX eligible for Social Security. #265-72-0741. Subject is married and has a total of three dependents other than himself. Subject's dependents are XXXXXXX residing in the U.S. U.S. possessions, Canada, Mexico, the Canal Zone, or the Republic of Panama. Subject will submit a covert tax return per DIR-25958, 20

7. Operational Expenses. When properly authorized, Subject will be reimbursed for:

a. Operational travel including mileage claims for official use of his personal automobile.

b. Operational hotel expenses, meals, telephone calls, etc.

8. Other Commitments. Bonus. With prior approval of the Chief of Station a bonus may be authorized for outstanding performance in the line of duty. The amount of the bonus will be commensurate with the risks taken and the results which were achieved; amount not to exceed \$100.00 per any single bonus payment. In the event of Subject's death in the line of duty, an amount not to exceed \$5,000.00 will be paid to Subject's estate.

9. Contingent Obligations. No commitments other than those stated above have been made to the Subject.
