1. As Headquarters is already aware, a Latin American Conference to Study the Situation of the Jewish Minority in the Soviet Union (Conferencia Latinoamericana de Estudios sobre la Situación de la Minoría Judía en la URSS) was held in Mexico City during the period 13 - 15 May 1966. Judging by numerous articles in the press, Política, La Voz de México, Sucesos Para Todos (see attachments under separate cover) and excerpts from conversations between numerous persons on LIENVOY and LIFEAT, the Soviet Embassy, the Mexican Communist Party (PCM - Partido Comunista Mexicano) and other groups and individual Communists were determined, if possible, to prevent the Conference from being held and, failing that, to discredit it completely and pin the ODYOKE/ODACID label on it. Despite their efforts and the voluminous adverse propaganda, both before and after the Conference, the Conference was held and was probably mildly successful.

2. Política, 1 May 1966, carried an article attacking the proposed Conference and ridiculing some of the Mexican participants (Attachment A). It contains, among other things, a partial reprint of the text of an interview or statement by Nicolas S. Leonov, Press Attaché of the Soviet Embassy, in which he states that Mexico should not be drawn into the cold war propaganda battle, and he maintains that Jews in the Soviet Union are not mistreated or discriminated against. In addition to the attacks and counterattacks in the press, efforts were made (based on LIFEAT on Enrique SEMO Colev, Gerard PIERRE-CHARLES, and LIENVOY) to prevent Carlos Pellicer, a darling of the Mexican left but not a formal PCM member, from taking part; Pellicer is an official of the Mexican Committee for the Defense of the Jews in the USSR (Comité Mexicano Pro Defensa de los Judíos en la Unión Soviética). (Attachment B) continued the attack on the Conference and its participants, claiming in effect that it is a clear anti-Soviet move backed by ODACID. As of 18 May, according to the article, numerous signatures had been collected on a "progressive manifesto" protesting the Conference. The list includes many well known Mexican Communists and pro-Communists. Attached also (Attachment C) is a copy of the "progressive manifesto", which was published in El Día on 17 May 1966, and a copy of a manifesto (Attachment D) published in El Heraldo, 22 April 1966, by the Mexican Committee for the Defense of the Jews in the USSR, in which a number of demands are made on the Soviet Government with respect to the Jews and their rights.

3. La Voz de Mexico, 15 May 1966 (Attachment E) carried an article bitterly attacking the Conference, which it charges is being organized and held by groups and persons in the service of ODACID. It specifically names LICOOKY-1, although the latter's name is incorrectly spelled, as one of those responsible for the Conference and says she is "well connected" with ODYORKE police. Sucesos, 21 May 1966, carried an article (Attachment F) attacking the Conference and its organizers and charging that there are sinister forces behind the Conference. This article carries a picture of LICOOKY-1.

4. Sucesos, 4 June 1966, included an inserted sheet (not found in all copies of this edition) entitled "An Agent of the FBI and INTERPOL in the Association of Mexican Writers," which deals almost exclusively with LICOOKY-1, her expulsion from Cuba, work in Mexico, and contacts and activities in Mexico. It charges that in Mexico she is working for Daniel James, who is responsible to KULARK (Attachment G).

5. LICOOKY-1's name appeared in a notice (Attachment H) appearing in El Excelsior, 26 May 1966 by Vicente Echeverría del Prado, treasurer of the Mexican Association of Writers (AEM - Asociación de Escritores de México, A.C.), which simply stated that LICOOKY-1 is not authorized to accept dues or handle other business of the AEM within the province of the treasurer's duties and obligations. However, in view of the adverse publicity previously, the announcement had the effect or implied that the AEM or members of that group believed the charges that LICOOKY-1 had a part in organizing the Conference and/or is an agent of KULARK. The notice, as it appears, also implies that LICOOKY-1 was mishandling AEMAC funds. Echeverría offered to publish the clarification on the sheet on which the AEMAC announcement appears; however, LICOOKY-1 asked him not to do so and said she would take up the notice and any clarification with the AEMAC Justice and Honor Commission.

6. On 9 June 1966 while conversing with SEMD (Attachment I), Leonov said that LICOOKY-1 had called him to say that she had had nothing to do with the Conference, and does not want the Soviets to catalogue her as an enemy. Leonov commented that LICOOKY-1 had left him her phone number and had asked him to help her (presumably refute the charges that she was involved with the Conference). The LILDEK case officer who currently handles LICOOKY-1 said on the morning of 14 June 1966 that LICOOKY-1 told him she had called the Soviet Press Attaché to deny that she had had anything to do with the Conference "because it is what she would normally do." She did not, however, mention beforehand that she intended to call the Soviet Embassy. (Part of conversation is forwarded as Attachment J.)

7. The Station believes that most or all articles attacking the Conference, and particularly those attacking LICOCKY-1, were Soviet inspired, and it is further believed that SEMO wrote most if not all articles attacking the Conference which appeared in La Voz, Politica and Successos. The Soviets, who are probably aware of previous Cuban charges that LICOCKY-1 is an ODYORKE agent, probably feel that as an American closely associated with the AEMAC LICOCKY-1 would be vulnerable to such an attack.

8. As a result of the Successos article of 4 June 1966 an official from the Ministry of Government did visit LICOCKY-1 to check on her documentation. The official said that he did not believe the charges made in the Successos article, but since her tourist visa had expired he advised her to immediately leave the country in order to renew it, and he provided her with a letter to show to Mexican border authorities permitting her exit. She is currently in FORPDE but is expected to return to Mexico in a few days.

9. As Headquarters is aware, LICOCKY-1 will be terminated effective 30 June 1966; the decision to terminate her was made some time ago, prior to the occurrence of the Conference and the resulting adverse propaganda. While she may be of some occasional use should she return to and remain in Mexico, it is believed that the recent adverse propaganda has impaired her future usefulness in Mexico, although many Mexicans undoubtedly do not believe the charges and others offered to "come to her defense."

10. A dispatch will be prepared and forwarded when the termination has been completed, and any new developments with respect to her alleged participation in the above Conference will be included in that dispatch.

<p>1. Attached is a newspaper article which appeared in <u>Excelsior</u> of 8 May 1966 on this subject. Station had a considerably more detailed report from LICCONY-1 on the same subject which she obtained from Mario MONTEFORTE Toledo, who attended as a Mexican delegate. Unfortunately before this report could be disseminated, we were scooped by the newspaper. At any rate, there are elaborating comments which may make it more useful:</p> <p>a. Monteforte, on arriving in Arica, already had a plan on the structure and functions of the <u>comunidades</u>, and since no one else did, he claimed virtually to have directed the Congress.</p> <p>b. A provisional secretariat was formed in Arica to organize the Second Congress of the Latin American Cultural Community. This consisted of: the Chilean writers Luis CYARMUN, essayist and Dean of the Faculty of Plastic Arts of the National University of Chile; Nicanor PARMA, poet and mathematician; Sergio VODANOVIC, dramatist. The Second Congress was planned for Mexico in 1967.</p> <p>c. To oversee the formation of the Latin American Community of Writers, an affiliation commission was formed consisting of the following: Carlos PELlicer and Juan RULFO for Mexico and the Caribbean; Izu SALARRUE and Ernesto CARDENAL for Central America; Benjamin CARRION and Jorge ZALAMEA for the Greater Colombia</p>

zone; Tristan de ATHAYDE and Jorge AMADO for Brazil; Juan Carlos ONETTI and Jose Luis ROMERO for the River Plate area; Jose Santos GONZALEZ Vera and Fernando ALEGRIA for Chile, Peru and Bolivia.

- d. The affiliation commission will form the initial body of writers of the Community within a six-month period. Thereafter, acceptance of new members will be suspended for six months, but will then be renewed in order to facilitate the work of organizing the Second Congress of the Latin American Cultural Community.
- 2. Carlos Pellicer and Juan Rulfo are respectively the president and vice-president of the Asociacion de Escritores Mexicanos, A.C. (Association of Mexican Writers - AEMAC), see MEXI-6177 of 5 February 1966, an organization dedicated ostensibly to bettering the welfare of writers through increased fringe benefits as well as better publication and distribution of their works. Its constitution specifically forbade its involvement in political affairs or entanglement with international organizations. Mario Monteforte is a member of this organization. During recent months, under the aegis of Pellicer and Rulfo, efforts have been underway to revise this constitution in such a way as to repeal these provisions without at the same time alienating those of the members who are opposed to dropping these provisions. Pellicer, it will be remembered, attended the COMES meeting in Genoa last year, at which the formation of the CIE was discussed.
3. Despite the vagueness of the wording of articles 3, 4 and 5 (see numbering in attached news clipping) there is no disputing their political nature. Monteforte alleged to LICOOKY that he did not feel the wording of these three articles is beyond the bounds of reason for a "non-political" organization. LICOOKY concedes that their wording is subject to the broadest interpretation if Monteforte should ever lose the "conductor's baton." Both are guilty of disingenuousness or at best naivete, since these articles seem to us to be not only a license, but almost a battle cry for political militancy from community members.
4. During his trip, Monteforte claims to have met the Chilean President and the Foreign Minister. The former, with whom Monteforte discussed the idea of the comunidades, agreed to write to President Gustavo Diaz Ordaz of Mexico stressing to him the importance of support for the comunidades. The implication is that Mexico's financial and moral support for the next Cultural Congress will be sought in this way.

5. The organizing commission for the Caribbean section of the Comunidad Latinoamericana de Escritores (Community of Latin American Writers - CLE) has begun issuing invitations to both individuals and organizations to join. The AEMAC has received such an invitation, but legally still must change its constitution before it can join. The letter of invitation did not reprint the basic principles of the CCCL to which the invited organization would be expected to subscribe. Whether this was a deliberate omission in the nature of entrapment, or whether it was felt articles such as the attached had adequately covered the ground, is not known.

6. Owing to LICOOKY-1's planned departure from the area the end of June 1966, it is not likely Station will have the same insight into the progress of the CLE.

<p>Reference: HEMA-27358, 7 October 1965</p> <p>1. Station regrets the delay in keeping Headquarters informed of the progress of our association with LICOOKY-1. When the proposed amendment to the LIREAM Project involving LICOOKY was turned down, we informed her on her return to Mexico that we could no longer justify the continued association at the present rate since we were simply not getting enough out of it, but that if she could regularize her status here and obtain working papers, we would be more than happy to conclude a new arrangement with her. She felt there was little chance of this, and we then told her we would conclude our arrangement with her sometime in the summer. As indicated in paragraph 2 of the attachment, the date has now been established as 30 June, at which time all outstanding financial arrangements with her will be terminated and she will be given her air fare to New York.</p> <p>2. Unfortunately, LICOOKY-1 seems to be incapable of realizing which side her bread is buttered on, at least here in Mexico. She cannot parcel her time out to her various interests, and therefore finds all her time taken up by her unpaid AEMAC duties. The profiles we have been harping on have not materialized except for the one submitted under HEMA-28831. We still hope for one on Francisco VILLAGRAN Kramer and such of the Mexican literary figures as amount in her judgment to "non-pigmies." We are not sanguine. We are still after a copy of Osegueda's paper on university reform.</p>

1. Production

- a. LICOOKY-1 has continued to devote the bulk of her time to the Mexican Writers' Association (AEM). She continues to handle most of its administrative work. She also organizes and does most of the work on the majority of the projects or activities which the AEM sponsors.
- b. L-1 continued to report on efforts to establish the Latin American Writers' Community (CLE), including the results of the Organizing Congress in Arica, Chile. She reported on the steps taken by Mario Monteforte Toledo in beginning preparations for an early 1967 Congress in Mexico and on the AEM's probable role in helping organize that Congress.
- c. L-1 supplied information on reactions among the Central American community in Mexico to the Guatemalan election campaign and results.
- d. She maintained contact with and reported on individuals of interest to the Station, including Monteforte Toledo, Carlos Pellicer Cámara, Manuel Germán Parra, Francisco Villagran Kramer, and Raúl Osegueda Pelala.

- a. LICOOKY-2 continued to report travel of Communists or leftists from Central America to Eastern Europe. During this period he reported on eight such travelers.

2. Operations

- a. L-1 has been notified that she will be terminated effective 30 June. She has been given the following requirements to be fulfilled before that date.

Provide profiles on the personality and politics of significant Mexican and Central American intellectuals with whom she is acquainted.

Obtain information on the newly-formed Latin American Writers' Community, its probable political development, and progress toward the holding of its scheduled meeting in Mexico City in January 1967.

Obtain a copy of the analysis written by Raúl Osegueda Pelala of the problems of autonomous universities.

Special tasks such as reporting on the activity of Stasia Madrigal and on the UNAM student strike.

- b. In order to accomplish the above tasks in the short time remaining, L-1 will be forced to curtail her ac-

tivities at the AEM. There are enough jobs that need doing at AEM to occupy her full-time and therefore the immediate partial withdrawal from AEM work is a prerequisite to the accomplishment of these assignments.

- c. Because L-1 has played such a key role in all AEM activities, and therefore in determining the direction and scope of these activities, her sudden withdrawal could result in important changes within AEM. Any major change in direction by AEM would probably become predictable once the identity of the person or persons who will move in to fill the vacancy left by L-1 become known. By having L-1 step aside now, rather than waiting until she is ready to leave Mexico, she may then be able to provide Station with an accurate account of any change resulting from her withdrawal.
- d. L-2 has not been met regularly since 25 January. On that date she was given a mailing address which she uses to request a meeting only if he has information to report. L-2 is paid on a piece-rate basis for information supplied and does not receive a regular salary.

Handling of LICOOKY-1 was taken over by Gary H. Reylander, from Howard T. Etsinger, on 12 January 1966.

### 5. Plans

It is possible that L-2 will, in the very near future, lose access to the travel information which he has been reporting, i cause he is being given new responsibilities in the office where he works. L-2 is intelligent, conscientious, and well-motivated. If he does lose his present access, the Station will consider him for other assignments in which he could be useful.

**EL MAESTRO** Carlos Pellicer, aparte ser uno de los más prolíficos y notables poetas mexicanos contemporáneos, un museógrafo de primerísimo orden y sobre todo conocedor profundo de las artes indígenas prehispánicas, es, al mismo tiempo, un personaje de lo más activo que igualmente firma un llamado de conciencia en defensa de los juicios, que protesta contra la encarcelación

de escritores o que preside la Asociación de Escritores de México, reparto por las calles volantes contra la guerra del Vietnam o preside la Comisión de Afiliación para la Comunidad Latinoamericana de Escritores, Delegación para México y el Caribe, junto con Juan Rulfo.

Podría decirse sin fallar a la verdad que cualquiera que pretenda luchar por una

causa justa y noble y que desea que sus actos vayan avalados por una persona de prestigio intelectual, de mérito singular, conocida en México y en el extranjero, encontrará en Carlos Pellicer no solamente a la persona ideal, sino a un hombre lleno de entusiasmo juvenil que se entregará a la tarea con todas sus fuerzas.

Para pequeña apología institucional, tiene por objeto recomendar a los escritores mexicanos la calidad reconocida, el valor que Pellicer y Rulfo han desarrollado en la formación de la delegación mexicana y del Caribe a la mencionada Comunidad Latinoamericana de Escritores, dependiente de la Comisión Cultural Latinoamericana, que bajo los auspicios de la Comisión Nacional de Cultura, de Chile, se efectúa en aquel país en los meses de enero y febrero pasados, con la asistencia de 102 intelectuales de países de América Latina.

**LA TAREA** de la Comisión de Literatura del Primer CCCL fue precisamente la de fundar la CLE y la de sentar las bases estatutarias de la misma, que son las siguientes: fomentar la unidad y el desarrollo de una cultura latinoamericana; intensificar el intercambio entre esta cultura y las de otras regiones del mundo; participar en las tareas culturales de la integración socioeconómica de la región y proponer sus propias iniciativas a gobiernos y organismos internacionales en igual sentido; velar activamente por la emancipación y el progreso económico y político de la América Latina; para asegurar a todos los sectores de la población un acceso pleno a los beneficios de la cultura.

Además, la responsabilidad plena de esta organización es el estudio de sus problemas y su solución, como también en la lucha latente y abierta contra gobiernos y personas que amenacen al sector en su persona y en la libre expresión de su pensamiento.

Cooperar en la realización de planes conjuntos destinados a la investigación y evaluación de la cultura latinoamericana, con el fin de fortalecer un sentimiento colectivo de la misma; correlacionar sus esfuerzos con los sectores de intelectuales, artistas y científicos, que integran la Comunidad Cultural Latinoamericana; crear instrumentos que faciliten la intercomunicación entre los escritores, y la producción, distribución y difusión de sus obras; y, finalmente, defender los intereses profesionales de los escritores, tratando de crear, además, condiciones para su independencia política.

La Comisión de Literatura llegó a otros acuerdos prácticos sobre mercado común del libro, circulación adecuada de bienes culturales, creación de una agencia literaria, redacción de una historia de América, superando particularismos, difusión de cátedras de cultura de la región, etcétera.

La Comisión de Literatura para México y el Caribe deberá sujetar sus actividades a los siguientes puntos básicos con respecto a la invitación que hayan de hacer a los escritores que consideren con los méritos necesarios para ingresar a la Comunidad Latinoamericana de Escritores: los candidatos deberán aceptar los principios de la Comunidad y copiar con obra publicada que contribuya al desarrollo cultural de Latinoamérica; podrán ingresar también las organizaciones de escritores, de importancia nacional, identificadas con esos mismos principios o que los acepten oficialmente; por último, los escritores figurarán y actuarán dentro de la Comunidad individualmente, y cada organización por medio de un delegado.

Como puede apreciarse por lo expuesto hasta aquí, las finalidades de la CLE no pueden ser mejores ni más altas, y la Comisión de Afiliación no pudo quedar mejor integrada, ya que a lo dicho sobre Pellicer hay que añadir que en las mismas condiciones está Juan Rulfo, otra auténtica gloria literaria de México.

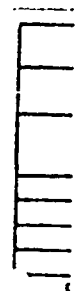

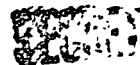

- d. LICOOKY-1 attended an AEM Board of Directors Meeting on 25 August 1965 called by Pellicer. At this meeting Pellicer explained how he had been elected President of the CLE for Latin America and detailed his plans for hosting the CLE Conference in Mexico City in early 1966.
- e. LICOOKY-1 had tipped off some of her rightist friends on the AEM Board of Directors who immediately protested. Instead of anything being arranged a committee of two was appointed to investigate and report back to the Board of Directors at a meeting to be held during the middle of October. This committee is composed of <sup>José</sup> ~~(Jose)~~ Ségura Millán and <sup>José</sup> ~~(Jose)~~ Martínez Sotomayor, friends of LICOOKY-1 who have assured LICOOKY-1 they will return a negative report opposing Pellicer's plan to use the AEM as host for the 1966 meeting of the CLE in Mexico.
- f. Pellicer had asked the Ministry of Education to finance this 1966 meeting in the name of the AEM prior to the 25 August 1965 meeting of the AEM's Board of Directors. If in the October meeting the Board of

Directors refuses to host the meeting it will put Pellicer in an embarrassing position vis a vis the Ministry of Education.

- g. LICOOKY-1 assured her CO she would return in plenty of time to attend the October Board Meeting and to arrange support for Segura and Martínez at this meeting.
- h. During the reporting period LICOOKY-1 has maintained contact with Mario Monterforte Toledo, Francisco Villagran Kramer, Margarita Paz Paredes, Juan Rulfo, Miguel Guardia Ríos, Leopoldo Zea, Luis Villoro, Alejandro Finisterre, Benjamín Carrión, Raúl Osegueda Pelala, Bartolomé Costa-Amic and Antonio Montes de Oca.
- i. LICOOKY-2 continues to report on travel of Communists or leftists from Central America to the Communist bloc. During the period covered by this report he has reported on 34 such travelers.

1. LICOOKY-1's efforts as described in reference have substantial merit and some potential particularly if the Station can find a way to tie them in with the LIREAM effort in the intellectual field.

2. LICOOKY-1 certainly is to be commended for her effort in getting writers both of the right and left such as Carlos PELLICER Camara to join the AEM. From a KUBARK standpoint the most interesting contact is the one with PELLICER because he has been the reported force behind the COMES/CLE effort in Mexico.

3. Although her assigned tasks as reported in para 7 a, l and d of the LILINK memo do not entail making her witting of other Station assets engaged in MHSPAWN Ops among the intellectuals, an amendment to her OA is required, and one has been requested. If her efforts progress to the point where she might be able to influence leftist writers in their efforts to establish the CLE in Mexico (para 7 c of LILINK memo) Headquarters should be forwarded your ideas on why and how LICOOKY-1 should be used as an active MHSPAWN agent, and another amendment will be required for this role.

4. ANDRIETTE will discuss this operation with the Station during his TDY.

5. In view if the restricted OA which confines KUBARK's association with LICOOKY-1, it is important that Headquarters remain aware of any unusual activity in her personal life which might affect her security or the granting of amendments to her OA for individual operations. Therefore, we would appreciate your keeping us informed on a more timely basis of any undertakings such as the recruitments for membership in the AEM described in reference.

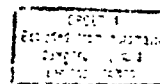

1. Production

- a. Beginning in early April, LICOOKY-1 was instructed to devote as much time as necessary to her work in the Mexican Writers Association (AEM - Asociación de Escritores de Mexico). LICOOKY-1 has been almost totally responsible for the AEM's development and present organization and is a member of its Board of Directors, which enables her to attend all Board meetings. This assignment was the result of KUBARK's interest in the activities of the European Community of Writers (COMES - Comunita Europea degli Scrittori) and its efforts to establish a Latin American branch.
- b. An operational dispatch covering LICOOKY-1's activities in the AEM in detail was prepared and forwarded. Two HMMs were prepared covering the organization of the AEM and Juan Rulfo's planning in conjunction with Carlos Pellicer Cámara (not to be confused with Carlos Manuel Pellecer), Miguel Angel Asturias, Arnaldo Orfila Reymal, and Benjamin Carrión for the Congress of the Community of Latin American Writers (CLE - Comunidad Latinoamericana de Escritores) to be held in Mexico City in 1966.
- c. LICOOKY-1 sees Juan Rulfo regularly and meets once a week with Pellicer, which enables her to keep current on their plans and activities.
- d. LICOOKY-1 provided information on ESLIME-1 prior to his recruitment which supplemented that given by LINLUCK. (LICOOKY-1 recommended against the direct recruitment of ESLIME-1 for reasons which later proved to be true.)
- e. LICOOKY-1 provided a detailed profile on Manuel German Parra and has an open channel to him for future contacts and assessment.
- f. LICOOKY-1 has provided information on the activities of Francisco Villagran Kramer, who is now living in Mexico. He and his wife and LICOOKY-1 exchange visits at each others apartments and they attended

one dinner party given by LICOOKY-1 which was also attended by Victor Alba, Djuka Julius, Mario Monteforte Toledo, and Dr. Frank Tannenbaum.

g. LICOOKY-1 continues supplying operational information on Margarita Paz Paredes, Djuka Julius, and other persons of interest to the Station.

h. The Station KUCAGE officers are now considering a plan suggested by LICOOKY-1 which would help sabotage any effort to take the AEM into the CLE.

i. LICOOKY-2 continues to report on the travel of Communists or leftists from Central America to the Communist bloc. During the period covered by this report, he reported on 11 individuals, all of whom traveled to the Soviet Union or Eastern Europe.

2. Operations

a. LICOOKY-1 will continue to cover the activities of those planning for the CLE Congress, the developments within the AEM, and will maintain her contacts with Central American Communists and exiles in Mexico City. This latter task has not been as successful as was originally planned because her access has been limited for the reasons outlined in Paragraph 5 of Reference A.

b. LICOOKY-1 has been given the following requirements in regard to the AEM:

- (1) To prepare complete assessments on all the influential AEM leaders.
- (2) To provide a detailed account of LICOOKY-1's influence (leverage) on them as a basis for;
- (3) Using the AEM, when the time comes, to keep Rulfo et al from forming an affiliate in Mexico, preparatory to the CLE Congress.
- (4) To continue developing a close friendship with Rulfo and Pollicer.
- (5) To continue her activities in the AEM in a manner to enhance her stature and increase the leaders' confidence in her as one who gets things done.

c. LICOOKY-2 is not used in any capacity other than reporting travel information to which he has natural access.

1. Attached is a LILINK Unit Memorandum concerning LICOOCKY-1's participation in the organization and direction of the Mexican Writers' Association (AEM). The memo outlines the Station's plans for using LICOOCKY-1 and the AEM for MSPAWN purposes.

2. This effort will be closely coordinated with the LIREAM Project, through which parallel (but independent) actions might be taken vis-a-vis the AEM (GRIFFIN is a member) and selected Mexican intellectuals to supplement the LICOOCKY-1/AEM operation.

3. Headquarters comments are solicited. If it should be deemed necessary to amend LICOOCKY-1's OA to permit this activity, Headquarters is requested to initiate this action.

1. The first steps to organize the Mexican Writers' Association (AEM - Asociación de Escritores de México) were taken in February of 1964 after Bartolome Costa-Amic and the Zaplana Bookstores published a proposal in the metropolitan newspapers, offering to establish a new series of library prizes and urging the Mexican writers to join an association that could provide material benefits for its members. The first meeting of the AEM was held on 11 August 1964. For some time the AEM remained as insignificant as other similar organizations which had been organized from time to time, such as the Society of Literary Authors and The Society of Friends of Mexican Books which never achieved any effectiveness or respectability. Mexico's established and well known writers have always shunned these organizations.

2. LICOOKY-1 became interested in the AEM through her friendship with Costa-Amic and saw the possibility of building the AEM into an organization which would include the middle of the road and right wing authors who had been systematically boycotted since the Lázaro Cárdenas' regime when Narciso Bassols, a member of the Communist Party, was Minister of Education.

3. LICOOKY-1 began a one man campaign of recruiting relatively well known right wing writers who could not be considered mediocre or nonentities. As LICOOKY-1's campaign began to succeed it became easier to recruit the more important writers of Mexico covering the whole political spectrum. In October of 1964, LICOOKY-1

persuaded Carlos Pellicer Cámara, well known Mexican poet, to join the AEM. It then became easier to get other well known writers to join. In all LICOOCKY-1 recruited about 80 of the well known Mexican writers to come into the AEM. At this time LICOOCKY-1 knew nothing of the European Community of Writers (COMES - Comunità Europea degli Scrittori) or plans to form a Community of Latin American Writers (CLE - Comunidad Latinoamericana de Escritores).

4. LICOOCKY-1 has been appointed to the Board of Directors of the AEM which permits LICOOCKY-1 to attend all Board Meetings and she is relied upon to do all details of organization and planning the AEM projects to assist the Mexican writer which is the ultimate objective of the AEM.

5. In this work LICOOCKY-1 has developed friendships with the leaders of the AEM including Pellicer and Juan Rulfo, both of whom were Mexican delegates to the COMES Conference held in Geneva, Switzerland during the winter of 1965. Pellicer has invited LICOOCKY-1 to his home and confers with her on AEM problems, usually once a week. She has free entrance to Rulfo's office at the Instituto Indigenista and he has visited LICOOCKY-1's apartment.

6. The Station hopes that through LICOOCKY-1 the AEM can be used to defeat any attempts by COMES through its affiliate CLE to form

a Unity of Writers (UE - Unidad de Escritores) in Mexico as well as sabotage the CLE Congress to be held in Mexico in 1966.

7. To this end, one of LICOOCKY-1's principal objectives is to solidify her acceptance in the AEM and she has been given the immediate tasks of:

- a. Preparing complete assessments and personality data on all of the influential AEM leaders.
- b. Determining LICOOCKY-1's influence on them as a basis for;
- c. Using the AEM, when the time comes, to keep Pellicer and Rulfo from forming the UE affiliate in Mexico, preparatory to the coming CLE Congress.
- d. LICOOCKY-1 is to continue her work in the AEM and to try to become a close confidant of Pellicer, Rulfo and other influential leaders of the AEM.

8. The Station plans to closely watch the development of the AEM and the plans and activities of Pellicer, Rulfo, Benjamin Carrión, Miguel Angel Asturias and others who may participate in planning for the forthcoming CLE Congress.

1. We were especially pleased to receive the LICOOKY/1 target survey on Subject (of 201-12972) and to learn that the Station has a controlled asset who enjoys direct, non-professional, social contact with Subject. As the Station is aware, Subject's extra-curricular activities have become a matter of increasing CI concern to a number of Stations in Latin America. However, none of them appears to have assets in sufficiently close contact with Subject to determine what he is actually doing and for whom. We realize, of course, that LICOOKY/1 probably will not be able to shed any light in this regard, but we hope that her contact can be exploited to provide the type of personal operational assessment data on Subject which we have largely lacked up to now.

2. Our information on Subject has so far been conflicting on the point of his suspected intelligence affiliation and about his possible susceptibility to recruitment. Nonetheless, we regard LICOOKY/1's views regarding Subject as objective and reasonable. During future contacts, we request that she concentrate on discerning Subject's personal attitudes and weaknesses or exploitable vulnerabilities. Should Subject be transferred laterally to another location in the West, we would like to try from the very outset of his assignment to undertake the type of gradual, long-term developmental contact which LICOOKY/1 suggested. To help us plan for the selection of an appropriate asset for this purpose, we believe it would be useful for LICOOKY/1 to prepare a personality profile on the type of individual to whom Subject is most likely to respond and who could hope to gain Subject's friendship and confidence with the least difficulty or disadvantage.

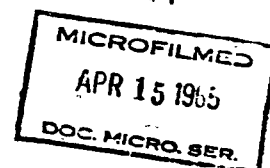

## 1. Production

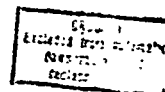
The LICOKEY Project has not produced any information reports during this reporting period. During this period LICOKEY-1 has been reporting on his activities and working as follows:

- a. L-1 learned that the Guatemalan PST have approached Bartolomé Costa-Rica about printing a "news letter" to be distributed in Guatemala. When this occurs she will be able to obtain copies and identify the authors and other pertinent details.
- b. Continuing reports on the activities of Miguel Angel Toralla Turres, Guatemalan guerrilla now in exile in Mexico. L-1 has established that Toralla meets Victor Manuel Gutierrez under a pseudonym at some undisclosed place and time.
- c. L-1 is attempting to identify and obtain the address and telephone of one "Mucrita". "Mucrita" acts as a courier to Guatemala for Gutierrez and also acts as a cut out between Gutierrez and Dr. Paul Osorio Palola. It has been established that Gutierrez always uses "Mucrita's" name to make his telephone calls. "Mucrita" also takes telephone calls for Gutierrez.
- d. L-1 is attempting to identify one "Don a Carranza", posing as a courier in Guatemala. It has been established that "Don a Carranza" is a pseudonym for a person who is

in contact with Miguel Torrella and apparently a Guatemalan living in Ciudad Hidalgo who is a part of the congo system between the Guatemalan Communist exiles in Mexico and Party Members in Guatemala.

- e. L-1 continues reporting target study data on Margarita Diz Parades and Jinks Julius.
- f. L-1 correlated basic target studies on Arelia Castillo Lacer, now Mexican ambassador to Austria, and Alejandro Gortiz Pascando, now Mexican ambassador to Panama.
- g. L-1 is preparing a target study on Victor Vronski, an advisor to the Secretary of Treasury.
- h. L-1 has been instructed to report as fully as possible on Ernesto Madero, former chief of affairs in Moscow and who now had a responsible position in the Foreign Office.
- i. L-1 is attempting to identify all Nicaraguan guerrillas now living in Mexico and being assisted by Nicorto Torres Andressa and to get a line on their activities.
- j. L-1 is also attempting to identify a group of Central Americans, Salvadoreans, Nicaraguans and Guatemalans, who are meeting with Luis Manuel Zuziga.
- k. L-1 has been instructed to try and locate ~~VICTOR~~ **VICOR** ~~star~~ and discover his present activities.
- l. L-1 has been the source of information which provided the foundation for an SA operation against the PCW. L-1 has been seeing Maria ~~Cruz~~ <sup>AND</sup> ~~Salas~~ <sup>X</sup> ~~to~~ <sup>X</sup> ~~Reynolds,~~ wife of

Jose Revueltas, Communist Party member personality in Mexico for the past several years, on a regular basis. Jose Revueltas has become an alcoholic and for the last several weeks has been living with an Indian girl. Mrs. Revueltas blames this situation of her husband's relationship with two brothers Arturo <sup>X</sup> and Jose <sup>X</sup> Filio and on Jose <sup>X</sup> Navarro. According to Mrs. Revueltas these three are engaged in smuggling contraband goods into Mexico and are also engaged in ~~drug~~ <sup>drug</sup> activities. Mrs. Revueltas claims that they use their smuggling channels to help the PCW pass items and bodies in and out of the country. Jose Revueltas was the contact man between this group and ~~Dr. ALFARO~~ <sup>Dr. ALFARO</sup> ~~Estueros~~ and ~~Luis~~ <sup>F</sup> ~~Aracel~~ who were interested in smuggling Guillermo <sup>F</sup> Roussel Bande accused of murdering Carlos Ferias Jimenez, both known Communists, out of the country. There has been speculation that this murder was the result of differences between the Pro-Soviet and Pro-Communist (China) groups of PCW. Mrs. Revueltas believes that if she could cause the arrest of the Filios and Navarro she could rescue her husband from their influence. At L-1's suggestion, she wrote an anonymous letter denouncing the Filios and Navarro, describing their activities, types of contraband and the addresses where the contraband was located. Mrs. Revueltas was told by L-1 she would give it to a friend of hers on the Narcotics Board in Mexico.

The letter was passed to the Station where it will reach the proper Mexican authorities. This may not work, but if the information provided by Mrs. Revueltas is true and the group is arrested, publicity plus additional help from the station's publicity can create a damaging scandal against the PRI.

L-1 has been and is being instructed of the requirements outlined in para 2 of Ref. . . .

L-1A-W-2 reported on 15 March that Judith Ferrato called her to send a ticket to San Jose, Costa Rica for Manuel Lora on to the person to whom he assigns it. The ticket was for travel from San Jose to Mexico City. On March 18 Ferrato called saying Lora was in the city and had not used the ticket but had given it to Sofia Carmen Lopez de Ferrato who travelled to Mexico on 21 March. Ferrato called again on 26 March making a reservation for Carmen de Ferrato's return to San Jose on 1 April.

L-2 took advantage of this phone call to remark to Ferrato that there had been little travel lately. She told him there was no explanation other than people were just not travelling. She said the same at there could be some movement of students this summer.

#### 2. Operations

In order to better control and guide L-1's work, two steps have been taken. Negotiations with L-1 have been directed toward blockings out and defining the goals one should achieve during the

next three months period. For each meeting she prepares an "activities report". In this report she outlines her activities for the preceding week, the tasks she was working on, the people she was in contact with and the results. She also lists the tasks she will work on during the coming week, the people she will see, etc.

L-1 is handicapped in this work since she has no control over her contacts and has to be extremely discreet in her eliciting of the facts. Many times her plans go awry since during a given conversation there is no opening to bring up the subject she wished to discuss.

#### 3. Security

Both LICO L-1 and L-2 appear to recognize the security implications of their work. Neither are curious about their case officers. They follow their instructions concerning the security of their meetings and comply with their case officers. During the reporting period there has been no evidence of any unusual security problems.

#### 4. Personnel

LICO L-1 has regained her good health and her morale is high. Now that she has a permanent base of operations, in that she has been apartment furnished and a telephone, she is resuming her regular contacts that were broken when she was ill and living in a series of <sup>differant</sup> locations.

During the longest case officer's contact with L-1, she has not represented a personality described in Part 3 of Ref 1. She

is an intelligent woman, and in all our meetings she has appeared mature and attentive. She has been prompt and reliable in her meetings. She discusses her problems clearly and accepts instruction and criticism without argument. She has responded well to instructions and has worked hard in trying to improve her reporting. She appears to be well adjusted to her environment which is most extremely trying at times.

In discussions concerning the Communist and leftist movements, she admitted that at one time she was influenced by their ideology, but as she had grown older and had observed some of their activities and personalities, she had lost all respect for them. She said that she had been fooled by Fidel Castro in his early days and had thought he would be good for Cuba, but as events have developed she has given her sister-in-law who had been originally. She also commented that in her talks with LINDEN, he had opened her eyes to the fallacy of the Communist ideology. In all of these conversations she has appeared sincere in her statements. In liaison with LINDEN appears to be based on team affection for him and not on promiscuity. The case officer has the impression that if there was not a present Mrs. LINDEN she would become a ally his wife. This is a problem that may have to be faced in the future.

LINDEN's conduct presents any potential problem. While his wife is a small one and his access is limited, his assignments are carried out conscientiously.

##### 5. Problems

There are no unusual problems presented by this project.

LISCOCKY-2 admitted the access to her communist contacts here had been hurt as a result of her known association with LINLUCK. at the time he publicly broke with the party. As an example of this, Miguel Toralla told her that Gutierrez had referred to LINLUCK and LISCOCKY-1 as "henries" of the party and that he had been reprimanded for seeing LINLUCK when he first arrived in town. He had been forbidden to see either one of them.

#### 6. Effectiveness

LISCOCKY-1's target studies and suggestions on possible recruitment approaches have been helpful. While her reporting for the ~~first~~ past month has not produced any Information Reports, it has kept the station aware of the activities in her particular area of concern. If she is successful in performing her tasks as outlined in the paragraph under "Production" above, such information will be useful to the station. LISCOCKY-2's effectiveness is limited to his narrow target, but such travel information that he does provide does serve a useful purpose.

#### 7. Plans

It is planned to continue the present direction and guidance given to LISCOCKY-1 in an effort to increase the quantity and quality of her production.

The same attention will be given to LISCOCKY-2.

1. LICOOKY-1 has been asked to prepare target studies on the official Yugoslavs whom she knows. Forwarded herewith is her first effort.

2. According to a more recent report from LICOOKY-1, she began giving English lessons to Maria JULIUS on 2 March. LICOOKY-1 further reported that she spoke with Djuka on the telephone on 20 February 1965, and Djuka told her that he had been very worried that he might have heart trouble since he had recently experienced brachycardia, uneven pulse beat, and extreme anxiety. However, the doctor told Djuka the week before that his heart showed no damage and that it was simply a case of "nerves".

3. Further information from LICOOKY-1 on the JULIUSES will be forwarded as received.

**Target Study of Julius Djuka**

**1. Address**

Subject rents apartment # 33 at Mariano Escobedo 692. The switchboard number of this apartment building is 25-18-34. To call subject, dial the switchboard number and ask for extension 33. He pays approximately \$1500 pesos (120.00 US\$) for this apartment.

**2. Physical Description**

Subject appears to be about 50 years old. He is not good-looking, medium height, thin brownish hair, very round face, large nose, and chubby figure. Source has been unable to determine his date of birth or place of birth other than that he was born in Yugoslavia. He is of Hungarian descent.

**3. Religion**

Subject is half-Jewish. While he has no obvious religious inclination he identifies himself as a Jew.

**4. Education**

Source has never heard him speak of attending any particular schools or universities. From his speech and writing and logical approach to problems he appears to have a high degree of intelligence. Subject speaks English and Spanish fluently.

**5. Military**

Subject was active in partisan fighting during World War II in Yugoslavia. He has expressed his gratitude and appreciation of the British role during this war. He believes the British saved his life when he was wounded behind the German lines and was rescued by British Commandos who took him to Italy where he was hospitalized.

**6. Profession**

Subject is a newspaper correspondent for Politica, a Communist Party newspaper in Yugoslavia. Before coming to Mexico he was located in Washington, D.C. He does his writing at home. He is paid a salary (amount unknown, see financial status). In his writing he is primarily concerned with inter-

national politics. He obtains his information through normal research, interviews, and trading information with other correspondents.

#### 7. Family

Subject's mother lives in Yugoslavia. He has children by a previous marriage who also live in Yugoslavia. His present wife is an extremely attractive woman who is 15 or 20 years his junior. Her name is Maria and she was formerly a member of a Yugoslav opera company. Maria hopes to return to a career as an opera singer. She hopes they will be reassigned to Washington where she feels there is a greater opportunity to study and reenter such a career.

#### 8. Financial Status

a. Source says that over the three years she has known Subject and his wife, his wife has always commented on how little money they have to live on. She complains that the cost of renting furnished apartments (1300-1800 pesos) was so much she had nothing left with which to buy clothes.

b. Subject never has any pocket money and several times on his return from trips to Cuba he didn't have taxi money for the fare from the airport to his home. Source has, however, never known of Subject borrowing money or buying on credit. Source describes him as definitely the type to "live within his means". This lack of money does not appear to disturb him since he exhibits no interest in material possessions.

#### 9. Hobbies

Subject has no interest in any particular sports or other common hobbies. He likes good music and the company and conversation of other writers. For relaxation he likes to go to Cuernavaca where he can sit and relax in the sun. In general he seems to be quite in love with life itself.

#### 10. Friends

a. He is not narrow-minded about the politics, nationality, or race of the persons with whom he associates. He considers Carl Miggall, correspondent of U.S. News and World Report and reputed to be an extreme right-winger, as his friend. Another close friend is Morris Rosenberg, an AP correspondent in Mexico whose wife is Yugoslav-Jewish and a daughter of a

Yugoslav who fled the country when the Communists took over. Subject is close to Mario Monteforte Toledo whom he addresses personally and respects as being very well informed. Subject also regards John Rottle and Dudley Froust as close friends. When Subject met Dr. Frank Tannenbaum at the party given by source a couple of weeks ago he made every effort to establish a friendly rapport. (When Subject had heard that Tannenbaum was coming to Mexico he told source he was extremely anxious to meet him and would be most appreciative if source could arrange an introduction.)

b. Subject probably sees Ernesto Madero about once a week. They run into each other at receptions and Subject sometimes visits Madero at his office where he goes for tips or background material. Source doesn't know of their having visited each other socially in their homes.

### 11. Enemies

Source has never heard Subject speak of anyone in a derogatory manner nor has she heard of anyone in her circle of acquaintances speak in unfriendly terms of him.

### 12. Attitudes

Subject has never exhibited any bias toward persons because of their race, religion, color, or nationality. He has never been vocally critical of capitalism or an ardent defender of communism. He has no phobia against Americans. He is hoping he will be reassigned to Washington. He has often expressed his admiration of Washington as a cultural center and apparently enjoys the wide range of contacts available there. (Tannenbaum told source that during his conversation with Subject, Subject had talked in terms of criticism of Fidel Castro and Cuba in general.)

### 13. Habits

There is no evidence that Subject is interested in gambling, drugs, etc. He drinks, but his personality doesn't change under the effects of alcohol. His chief weakness is young and pretty women. Although his wife is young and very attractive he likes to do the Don Juan bit whenever he has the opportunity.

### 14. Approach for Recruitment

Source doubts he could be recruited as a controlled agent by a Western Intelligence Service, particularly on a one-shot basis. He probably could not be compromised through his Don Juan habits. He probably would laugh at any threats of black-

mail. While he feels the pinch of lack of money, he couldn't be bought if it meant a clear conflict of idealism and native loyalty to his country.

b. Any approach would have to be made gradually, over a long time, based on a high intellectual plane and mutual friendship, during which time he could be reeducated ideologically. There is no certainty that this approach would be successful.

c. Source believes much of his knowledge could be tapped through much the same approach described in the paragraph immediately above but on the basis of trading information. It would have to appear to him that he was getting as much in return as he was giving. This person probably should be a recognized professional journalist.

#### 15. Continued Assessment

Maria has expressed a desire to improve her English, which is now extremely limited. About three weeks ago she asked source if she would help her. The lessons didn't start immediately as Maria became ill with the "grippe". The lessons were to begin either the last of this week (12 February 65) or the first of next week (15 February). Source plans to meet with Maria two or three times a week at Maria's home. As a result of these lessons, source will continue reporting items on Subject as she acquires them.

1. Attached is a LICOOKY Project Progress Report covering the period 7 December 1964 to 28 February 1965.

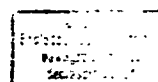

## 1. Production

*These bullet points  
about Licorny's  
activities in  
Germany*

a. LICORNY-1 was the source of the information contained in HMMA 0476, 0477, 0478, and 0529. L-1 has prepared target studies on Margarita Ben Orreda and Djuka Julius. Additionally, L-1 has provided other information of operational value. An example is the identification of one "Juanita", a cut-out between Dr. Raul Osagueda Polale and Victor Manuel Gutierrez Garlin, as Mrs. Rafael Carlos Gutierrez. "Juanita" also acts as a courier between Gutierrez and Guatemalan communists travelling between Mexico and Guatemala.

b. LICORNY-2 (L-2) reported on the travel of Judith Ferrato's nephew, Carlos Sautz, and his family to Costa Rica and on the planned travel of Manuel Mora to Mexico. He later reported the cancellation of this trip.

## 2. Operational

a. LICORNY-1's first task is to report on the plans, intentions, and activities of Central-American communist and leftists who reside in Mexico. She has also been assigned the task of preparing target studies of personalities of interest to the Station. Presently she is working on a target study on Victor Aguila. She is also gathering information of Scott Taylor, ex-wife of Carlos Gervetti, and on Gervetti himself.

b. L-1, in order to re-establish her contacts, gave "broilers" (code) gave a buffet on 21 January 1965 for Dr. Raul Osagueda and her visiting family. The guests at this buffet in addition to Ramonhou were: Dr. Raul Osagueda, Djuka Julius and his wife Maria, Manuel Sautz Ferra, Bartolome Costa-Ali, Paul Kennedy (New York Times Correspondent), and his wife, David Taylor (L-2) and wife, Marion Wilhel (Christian Science Monitor) and Dr. Teodor Karskovic and wife.

c. L-1 has arranged to give Judith Ferrato a week's work in Mexico. Through this contact she will be able to keep a target study on Djuka Julius current. L-1 is also performing the contact in keeping the target study on Margarita Ben Orreda current.

d. LICOBY-2 continues his task of reporting on the travel of Central American communists and leftists through his contact with Judith Ferrato.

e. LILINK-4 handles LICOBY-1 and LILINK-5 handles LICOBY-2.

### 3. Security

Handling these agents presents no unusual security risk.

### 4. Problems

a. LILINK-4 was introduced to LICOBY-1 on 5 December 1964. L-1 had left the hospital the day before after having been hospitalized with bronchial pneumonia. This illness had been complicated by an allergy to some antibiotic which had been administered. L-1 had a release on 3 December and returned to the hospital for several days.

b. It was discovered she had lost her apartment through the return of its owner and had been living in cheap hotels, pensions, and finally as a paying guest in the home of Elena Garro de Pan where L-1 has been sleeping on a pallet in a vacant room. L-1 and Elena had quarrelled and L-1 had to leave. She had rented an unfurnished apartment and had borrowed a cot from a friend. This squalid type existence had contributed to her illness and had left her without a base where she could invite her contacts or where they could reach her by telephone. The Station has helped her furnish her apartment which is modest but respectable. She has now recovered her health and has a base of operations. As a result of having a presentable fixed base, she has been able to reestablish her contacts.

c. LICOBY-2 has not presented any problems.

### 5. Training

a. Since LICOBY-1's recovery and resumption of reporting, a great deal of time has been spent in an attempt to improve her reporting. There have been practice sessions where she has written out reports which were then criticized for lack of detail, identifications, etc. LILINK-4 has written drafts of information reports which in turn were critiqued by the Station. Her initial drafts have been returned to the LILINK Unit where they were critiqued and shown to L-1, indicating how they should have been written in the first place. This is not only helping L-1 but has been a valuable experience for the LILINK Unit's officers.

b. HICOMY-1 has also been given instruction in the preparation of target studies.

c. L-1 has been extremely attentive and receptive to this type of training and there has been a marked improvement in her reporting.

d. Both HICOMY-1 and -2 are continually cautioned concerning security in their methods of obtaining information and meetings.

6. Plans

a. HICOMY-1's training will be continued and will be pressed to enlarge her area of contacts.

b. HICOMY-2 will continue to report on travel as he has done in the past.
