- 1. Rosita (LNU) is a stewardess with Cubana Airlines. Prior to joining Cubana she was employed as a telephone switchboard operator by the Direction General de Inteligencia (General Directorate of Intelligence DGI).
- 2. Source described Rosita as being the daughter of a well-known Departamento de Seguridad del Estado (Department of State Security DSE) official or a DGI official, but more likely DSE. She is a synthetic strawberry blond and is about five feet six inches tall.
