Source believes that Henry is his true given name. Henry may theve been in the Cuban Merchant Marine prior to 1959.
- 2. Henry, a Negro, was born about 1935. He is about five feet eight inches tall, weighs about 140 pounds, and has a thin build. Henry has a pug nose, a thin face, a drooping lower lip, and no upper teeth. He speaks English.
