- "Juan Carlos" is an officer in the South American Section of the Departamento Ilegal (Illegal Department) of the Direccion General de Inteligencia (General Directorate of Intelligence -DGI). Prior to 1962 he was an attache at the Cuban Embassy in Chile, but due to a personal guarrel with "Ulises Delmar," of the Cuban Embassy in Chile, he was returned to Cuba.
- "Juan Carlos" was born in about 1940, He is five feet seven inches tall, weighs between 160 and 170 pounds, and has a heavy build. He has dark brown hair and light blue or green eves. 1
