Headquarters Comments

The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

It is requested that the addressees take no action on any of the individuals mentioned in the personality reports without first checking with this Agency.

1. "Juan Carlos" is an officer in the South American Section of the Departamento Ilegal (Illegal Department) of the Direccion General de Inteligencia (General Directorate of Intelligence - DGI). Prior to 1962 he was an attache at the Cuban Embassy in Chile, but due to a personal quarrel with "Ulises Delmar," of the Cuban Embassy in Chile, he was returned to Cuba.

2. "Juan Carlos" was born in about 1940. He is five feet seven inches tall, weighs between 160 and 170 pounds, and has a heavy build. He has dark brown hair and light blue or green eyes.

1. The records of this Agency reveal no identifiable information on "Juan Carlos."
