Headquarters Comment. The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

Ramon Cesar CUENCA is the chief of the Illegal Department for Central America, including Mexico and Panama, for the Direccion General de Inteligencia (DGI - General Directorate of Intelligence). In approximately September or October 1963 CUENCA went to Poland and was replaced in the Illegal Department by pseudonym: "MIKE." From December 1963 until February 1964 CUENCA was in Mexico and while there had interviews with Roberto CASTELLANOS of the El Salvador Communist Party.

Headquarters Comment.

- The records of this Agency reveal no additional identifiable information on Ramon Cesar CUENCA aside from that which was passed in the above referenced CSCI.
