TO SEND HIS BROTHER TO <sup>USA</sup> ON A SCHOLARSHIP. HE SAID BROTHER, A MEDICAL DOCTOR, IS CURRENTLY IN PERU ON A PERUVIAN SCHOLARSHIP, AFTER HAVING BEEN REFUSED <sup>US</sup> SCHOLARSHIP. (COMMENT: STATION FILES REFLECT THAT <sup>Tinck</sup> ~~XXXX~~'S BROTHER, ~~XXXX~~ IS A MEDICAL DOCTOR. HOWEVER, WE UNABLE CONFIRM WHETHER HE CURRENTLY IN PERU). <sup>Tinck</sup> ~~XXXX~~ SAID HE WOULD ALSO EXPECT A SALARY FROM <sup>US</sup> ~~XXXX~~, BUT DID NOT WANT IT DIRECTLY FROM HANDLER DUE FEAR OF BEING PHOTOGRAPHED RECEIVING MONEY FROM AN <sup>US</sup> ~~XXXX~~.
