3. THEY ASKED IF THEY HAD TO GO THROUGH AMBUD-1 AND WERE TOLD THEY COULD DEAL DIRECTLY WITH ⁰³(PETERS) PHONE NUMBER OF JUSTO FOR CONTACT IS FR-3-1306. THAT OF ROSS IS HI-3-7097. HOWEVER, LEAVE DISCRETION HAVE USE CUTOUTS.

4. NO COMMITMENTS WERE MADE. THEY WERE ASKED TO COOPERATE WITH AMBUD-1 TO GET ALONG WITH HIM AND USE HIM BUT NOT FIGHT HIM AND AFTER MAKING THIS ATTEMPT IF THEY STILL COULD NOT GET ALONG WITH AMBUD-1 WE WOULD NOT DENY SUPPORT.

5. THEY ASKED ABOUT TRAINING AND WERE TOLD THAT COULD BE HANDLED BY ⁰³(PETERS) ALONG WITH ALL OTHER BUSINESS.
