OGCLI ADDAIGUE. LOLINA appeared at the Literialical Airport at Merica, Success, Mexico, on Auguet 2, 1021, stating that he was a Guban situan who dosized to return to Cuba BODAIGUEL said that he was born in Jaruso, Envanz, CL., was 31 years old, married, an employee, and had his permanent residence at Calle Galeano SI., Envanz, Cuba.

RODAIGULE statel that he entered Mexico at the International Airport in Mexico City on January 21, 1981, and was granted political asylum.

RODRIGUE presented a cortificate of Cuban nationality issues by the Cuban Consulate in Merico City on July 27, 1981, and also exhibited a Similar Sertificate for his minor soa.

RODAIGUL state that the reasons for which he had requested political asylum in Eexico no longer were in effoct and he desired to renounce his status of political asylum in Mexico. The stated that he wanted to return to Cuba with his lf-month-old son, OCCAR WANTUR RODAIGUE.

Lo mentionod above, RODNIGUEL appeared at the Immigration office in Merida, Yucatan, Mexico, on August 9, 1961, and departed Merida, en route Mavana, Cuba, on August 16, 1961, accompanied by his son, OSCAR.

Mrs. MODRIGUEL, on Eeptomber 7, 1932, recuested authority from the hor husband to enter Hexico as an immigrant. Mrs. RODRIGUEZ stated that Mrs. ALENICA HONTERO DE SANCEES, owner of the Husva Kola Pharmacy in Hexico City, had offered him employment at a salary of SCO pesos (272 U.S.) monthly.

RODRIGUES Sit not accept this employment, and on February 3, 1004, <u>ECONS, SINCERE VIENTE</u>, owner of the Versalles Pharmacy, Mappins 30, Ecuico City, offered RODRIGUES employment in that pharmacy at a salary of 1,000 pesos (\$30 U.S.) mentury.

He was similted as an immigrant for a period of one your, since his will is a Mexican citizen by birth. He was admitted with permission to accept employment at the Versalles Pharmacy.

RODRIGUES entered Mexico at International Airport, Mexico City
