- B. 10 OCTOBER 1959: ACCORDING SAME OFFICIAL BRITISH TRAVEL RECORDS CSWALD LEFT LONDON THIS DATE BY AIR FOR HELSING.
- C. OCTOBER 1959: STOCKHOLM NEJSPAPER "DAGENS NYHETER" 25 NOVEMBER 1953 States Lee Oswald passed through smeden october 1959. Article ades that oswald un-SUCCESSFUL OBTAINING VISA TO USSR IN-HELSINKI WHICH RESULTED HIS RETURNING STOCKHOLM. TWO DAYS AFTER HE ARRIVED STOCKHOLM OSHALD TRAVELED DIRECTLY MOSCOW. CONCLUDING SENTENCE ARTICLE STATES "THIS INDICATES THAT RUSSIAN EMBASSY (STOCKHOLM) GAVE HIM A VISA." - F. 1962: OFFICIAL BRITISH RECORDS DO NOT REFLECT OSWALD RETURNED UNITED STATES FROM USSR THROUGH UNITED KINGDOM. HOWEVER IF HE WERE MERELY TRANSITING IT WOULD NOT HAVE HEEN NECESSARY FOR HIM FILL OUT LANDING CARD AND THEREFORE THERE WOULD BE NO RECORD HIS TRAVEL IN OFFICIAL TRAFFIC INDEX.
