1. HQS SERIOUSLY QUESTIONS UNSNAFU/9'S EMOTIONAL STABILITY AND LACK OF GOOD COMMON SENSE, AS DEMONSTRATED IN HIS AGREEING TO PARTICIPATE IN PURPORTED "JOKE" REF A AND BY HIS CONDUCT REF B. ADVISE U/9 ABSURDITY OF MANUEVER HE AND AMLASH/3 ATTEMPTED WITH MIRRLEES. IF A/3 WISHES TO LIVE UP TO HIS NICKNAME, HIS PRIVILEGE, BUT WE EXPECTED U/9 BE A MORE SERIOUS, MATURE AND INTELLIGENT INDIVIDUAL. SUGGEST STOCKWOOD OBTAIN COMPLETE EXPLANATION SITUATION FROM U/9.
