2. HQS HAS REPORTING THIS CASE IN REFS AND SUBSEQUENT CORRESPONDENCE, FROM WHICH APPARENT WHY KUBARK--AS OPPOSED AEPOSSE--REPORTS CHANNEL USED.

3. PLEASE EXPLAIN TO AEPOSSE. DAUCHAN WILL NOT RESPOND PENDING RECEIPT HQS ADVISE.
