A. ON 7 SEPT, EMBASSY DEFENCE ATTACHE'S OFFICE
RECEIVED PHONE CALL FROM INDIVIDUAL GIVING HIS NAME AS ~~AS~~
~~WHICH~~ WHICH CALLER IMPLIED WAS AN ALIAS. CLAIMED HE WAS
CALLING FROM PAY PHONE IN SCOTLAND AND GAVE THE NUMBER.

B. CALLER DISCUSSED U-2 INCIDENT AND STATED HE HAD
INFORMATION ON DEFECTORS ~~MARTIN~~ AND ~~MICHELL~~ HE CLAIMED
HE HAD PROOF THAT THEY DID NOT REACH USSR VIA MEXICO, BUT
TRAVELED THROUGH UK BOOING A SOVIET TRAWLER OFF EAST COAST
OF SCOTLAND. HE WANTED TO MEET SOMEONE FROM THE EMBASSY TO
WHOM HE COULD PASS ON HIS INFORMATION AND SAID HE WOULD CALL
AGAIN ON 12 SEPT. HE DID MAKE SECOND CALL ON 11 SEPT AND
IN RESPONSE TO REQUEST, GAVE WHAT APPEARS TO BE LEGITIMATE
PHONE NUMBER IN GLASGOW, SAYING IT WAS SISTER'S NUMBER. HE
REITERATED DESIRE THAT SOMEONE CONTACT HIM, SAID HE WOULD
